#### RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS TUESDAY, FEBRUARY 1, 2011

The Skagit County Board of Commissioners met in regular session on Tuesday, February 1, 2011, with Commissioners Ron Wesen, Kenneth A. Dahlstedt, and Sharon D. Dillon present.

# I. CALL TO ORDER:

Chairman Wesen called the proceedings to order at 10:00 a.m.

# II. PLEDGE OF ALLEGIANCE:

Chairman Wesen led the gallery in the salute to the flag.

# III. AGENDA:

- a) \*8:00 a.m. 9:30 a.m. Briefing County Commissioners/County Administrator
- b) 10:00 a.m. 10:30 a.m. Recognition: Official Opening of Samish Island Park

Brian Adams, Director of Parks, Recreation and Fair, was present and recognized Mike McCutchin, West Parks Lead, and Pauli Mickelson, Administration Coordinator, for their work on this project. Mr. Adams stated that partnerships are more important than ever and that this project would not have been possible without them. The entities which partnered to re-open the area are: Skagit County, the local Samish Island Community Association, the Department of Natural Resources (DNR), Skagit Land Trust, and multiple private land owners. Mr. Adams showed photographs of the area and of the steps leading to the beach area.

Chairman Wesen stated that the Bourn family gave the Department of Natural Resources the property in 1959 with the stipulation that it be used for public access, but that in July 2009 the department had to cut funding for park maintenance and the steps leading to the beach were removed. Chairman Wesen stated that after the community discussed their concerns regarding the closed beach, Brian Adams had been working to get access to the beach area restored. Chairman Wesen thanked everyone for their work and help on re-opening the beach area.

Commissioner Dahlstedt stated that this is a story with a happy ending. He thanked the property owners for their land donation and thanked the community for making this happen. He stated that he believes the county will be made whole from the bottom up. Recreation is important to Skagit County. He stated that the Department of Natural Resources had to make a hard decision when they decided to remove the steps and close access to the beach area. Commissioner Dahlstedt stated that he was glad that partnerships were put in place to re-open the area.

Commissioner Dillon recalled when the residents of Samish Island first came to the Commissioners to discuss this need. She thanked them for their dedication to keep the beach open to the public. Commissioner Dillon stated that she understood that this process took longer than expected, but that it was important to get everything properly in place before re-opening the beach. The partnerships formed made this possible and Commissioner Dillon is glad that the public, once again, has access to the beach area. She thanked everyone for their work.

Commissioner Dahlstedt read the plaque Honoring Joan Brady and presented her with the Skagit County Park Stewardship Award for the donation of land for the recreational benefit of the community.

Commissioner Dillon read the plaque Honoring Allen and Gwen Brown and presented them with the Skagit County Park Stewardship Award for the donation of land for the recreational benefit of the community.

Mr. Adams also wanted to recognize the Bourn family which donated this land many years ago for the use of the public. Mr. Adams stated that there was some confusion over land ownership when the partners were looking into ways to re-open access to the beach. This confusion, and the solution, slowed the process a little. Mr. Adams ended by saying that the servicing of the two parks in the area have been consolidated from two separate parties to one which saves the taxpayers money.

Mr. Allen Brown wanted to let the Commissioners know that there have never been any conflicts between the public using the beach areas and the private land owners and that when the neighborhood heard that the access to the beach was being closed, the neighborhood wanted to do what they could to keep it open. He thanked the Commissioners for helping make it happen.

Chairman Wesen recessed the proceedings.

- c) 10:30 a.m. 11:30 a.m. Public Works Henry Hash, Director:
  - 1. Work Session: Draft Integrated Pest Management Plan for Roads, Parks, and Open Space and the Draft Property and Facility Management Plan for Pollution Reduction

Chairman Wesen reconvened the proceedings at 10:30 a.m.

Michael See, Stormwater Permit Program Coordinator, stated that the main component of his job is to make sure that Skagit County is up-to-date with the National Pollutant Discharge Elimination System (NPDES). He discussed two documents with the Commissioners. The first was the Integrated Pest Management Plan for Roads, Parks and Open Space. The document contains the methodology for controlling pests which include both plants and insects. Control methods include cultural controls, biologic controls, and chemical controls. Mr. See stated that using chemicals to control a pest is used last, and when implemented, the least toxic method is tried first. The second document discussed was the Property and Facility Management Plan for Pollution Reduction.

Mr. See stated that Skagit County benefits from these Management Plans since it limits chemical application, protects the public, is cost-effective, protects critical areas, and allows Skagit County to comply with the NPDES permit requirements. Mr. See reviewed the Integrated Pest Management Plan with the Commissioners. He informed them that, while this is the first time that the plan has been in written format, employees had already been following the recommended pest management guidelines.

Commissioner Dahlstedt realizes that many people are wary of the agricultural industry when it comes to the application of fertilizers and pesticides. Commissioner Dahlstedt wanted to point out that pesticides, herbicides, and fertilizes are expensive, and heavily regulated and so farmers do not over apply any of these chemicals. Commissioner Dahlstedt believes what can be dangerous is the average consumer who can pick up pesticides or fertilizer at a local hardware store and over apply them. He stated that he understands that there can be a thought that if a little pesticide or fertilizer is good, then more would do an even better job which is not the case and he encouraged homeowners to apply these products correctly since excess chemicals goes directly into a local ditch, stream, river, and Puget Sound. He stated that education regarding our water systems should continue for the general public. Commissioner Dahlstedt thanked Mr. See for a job well done and is glad to set a good example for the rest of the county.

Mr. See pointed out that excess fertilizers and pesticides can be disposed of at the transfer station.

Commissioner Dillon recalls being adamant about not spraying near waterways. She stated that what she needed was to be educated about the process and application of chemicals. She stated that when applied correctly, chemicals will only treat what they are applied to. She shared the story of a correctly controlled application of chemicals near Lake Cavanaugh. After some plants were treated near the lake, the water was tested for multiple consecutive days and no trace of chemical showed up in the sample tests.

Chairman Wesen thanked Mr. See for his work. He agreed that education regarding our water systems and the correct application of chemicals is important. He understands that people tend to think that farmers are polluting the Puget Sound, but chemical tests from Puget Sound instead showed trace chemicals which are used by homeowners.

Mr. See stated that Public Works would prepare a resolution for the Board to sign to adopt the policies. Chairman Wesen recessed the proceedings at 10:50 a.m.

2. Miscellaneous

Public Works did not have any miscellaneous items to discuss.

d) 11:30 a.m. - 11:45 a.m. Public Comment Period

Chairman Wesen reconvened the proceedings at 11:30 a.m. Seeing no public comment forthcoming, Commissioner Dillon made a motion to close the public comment period, which was seconded by Commissioner Dahlstedt. The motion

passed unanimously.

Commissioner Dahlstedt wanted to share with the audience that he met with Governor Gregoire on behalf of Commissioners Wesen and Dillon last week along with representatives from seven of the other nine counties which are being proposed by Governor Gregoire to form a ferry district which would be in charge of entire ferry system rather than the state. The new ferry district would find ways to raise taxes and find funding for the entire system. Commissioner Dahlstedt questions if a smaller district should be responsible for operating and funding the ferries or if the state should remain responsible. He voiced concerns that if this moved forward, he would not want Skagit County taxed twice to fund the ferries. Commissioner Dahlstedt stated that the counties with the biggest population would probably have the most say in this matter.

Commissioner Dillon shared that various locations throughout Skagit County held a Stand Down for Veterans where volunteers gathered to provide free services. She stated that many volunteers showed up to help and she wanted to thank everyone involved.

Chairman Wesen and Commissioner Dahlstedt also attended a Stand Down. There are many Veterans struggling in the area and they stated that the word would continue to spread for the next Stand Down.

Chairman Wesen went on to inform those present that the Commissioners recently attended the United Way Campaign Celebration. Commissioner Dahlstedt continued by saying that United Way reaches out to help and fund multiple agencies doing work in the community for those in need. He stated that United Way was able to raise \$1 million dollars in 2010. 85% is dispersed to agencies serving Skagit County and 15% goes to cover administration costs. Many employees at Skagit County donate to United Way. Commissioner Dahlstedt pointed out that the Skagit County work force has gone down these last few years, but contributions to United Way by Skagit County employees has gone up. At the United Way Campaign Celebration, the Commissioners were presented with a plaque thanking all Skagit County Government Employees for their Outstanding Support in 2010. Commissioner Dahlstedt also pointed out that Skagit County employee, Dan Berentson, was awarded the Reep award for his exceptional support and campaign efforts on behalf of United Way.

Dan Berentson, Natural Resources Division Manager, stated that it was an honor to receive the award. He stated that he was proud of the Skagit County employees who have committed to contribute to United Way. Skagit County continues to grow in contribution amounts year to year.

Tim Holloran, County Administrator, echoed congratulations to Dan Berentson and Skagit County employees. Mr. Holloran stated that Ted Reep was one of the founders of United Way in Skagit County. He stated that non-profit agencies are the silent heroes among us that help meet the needs of many in our community.

The Commissioners thanked everyone again, and Chairman Wesen recessed the proceedings.
