RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS TUESDAY, SEPTEMBER 4, 2012

The Skagit County Board of Commissioners met in regular session on Tuesday, September 4, 2012, with Commissioners Kenneth A. Dahlstedt, Sharon D. Dillon, and Ron Wesen present.

I. CALL TO ORDER:

Chairman Dahlstedt called the proceedings to order at 10:30 a.m.

II. PLEDGE OF ALLEGIANCE:

Chairman Dahlstedt led the gallery in the salute to the flag.

III. AGENDA:

- a) *8:30 a.m. 10:30 a.m. Briefing County Commissioners/County Administrator
 - a) 10:30 a.m. 11:30 a.m. Public Hearing Regarding the Creation of a Rural Partial County Library District in the Unincorporated Precincts of the Sedro-Woolley School District

Chairman Dahlstedt opened the public hearing at 10:46 a.m.

Beverly Conn of 1817 Township Street in Sedro-Woolley stated that she was the Chairperson of the Sedro-Woolley Partial Rural County Library District Committee. She introduced the City of Sedro-Woolley Librarian Debra Peterson and members of the Partial Rural County Library District Committee Beverly Ringhouse, Marjean Burke, and Linda Morgan who were present in the gallery. Ms. Conn explained that the partial rural county district proposal was being brought forward because of the need to develop alternative ways to serve the needs of the rural residents.

Ms. Conn briefly explained that a rural partial county library district could be formed in a portion of the unincorporated area of a county if there were no rural county library district or inter-county rural library. She said the general boundaries would be the Sedro-Woolley School District with the exception of Lyman, Hamilton and the City of Sedro-Woolley. She indicated that Lyman and Hamilton would be asked if they would want to become part of the rural partial county library. She further explained that the City of Sedro-Woolley and the Library Board would need to agree to place a proposal of annexation on the ballot.

Ms. Conn said that there are approximately 10,500 citizens within the City of Sedro-Woolley and explained the services that were currently being provided by the City of Sedro-Woolley and the additional services that could be provided if the partial rural county library district was formed.

Chuck Diver of 26971 Panoroma Court in Sedro-Woolley asked whether the people that signed the petition would be responsible to pay the tax if the proposal were passed. A member in the gallery indicated that all the signers of petition were rural residents of the Sedro-Woolley School District.

Ed Bishop of 4950 Ida Drive in Sedro-Woolley stated that the additional taxes would cause him a hardship and asked whether the start up cost to form the rural library could be used to benefit the Sedro-Woolley Library. He requested that the Commissioners not approve the creation of the rural partial county library district.

Charlene Robinson of 31445 Barbin Road in Sedro-Woolley asked if the signatures were valid and why was the public hearing taking place. Ms. Robinson addressed some concerns with the creation of the rural partial county district and said that forcing rural residents to pay for library services was not fair

Chairman Dahlstedt explained that the purpose of the public hearing was to give the public an opportunity to comment on whether the Sedro-Woolley Partial County Library District should be placed on the ballot.

Dave McConnell of 27103 Helmick Road; David Anderson rural Sedro-Woolley resident; Catherine Longfellow of 5318 Cedar Ridge Place; Elizabeth Schweikert of 29082 Outlook Lane; Jim Justice of 27103 Helmick Road; Chris Hunter of 23490 Mosier Road all spoke in favor of the creation of the Sedro-Woolley Partial County Library District.

City of Sedro-Woolley Supervisor and Attorney Eron Berg of 325 Metcalf Street in Sedro-Woolley stated that the process for the creation of a rural partial county library was a two part process. He explained that if the rural partial county library district were approved by the voters, the money generated from taxes would not go to the City of Sedro-Woolley or the City's library and would not supplant any of the City's expenses for library services. He indicated that the second part of the process would be for the City and the rural partial county library district to work together to establish an agreement for library services.

Seeing no further public testimony forthcoming Commissioner Dillon motioned to close the public hearing at 11:10 a.m. Commissioner Wesen seconded the motion, which passed unanimously.

Commissioner Dillon indicated that she supported the idea of county-wide rural library districts and said there were some unanswered questions.

Commissioner Wesen said that he thought it was important to have a library services available. He expressed concerns about the management of the extra revenue.

Chairman Dahlstedt indicated that he supported county-wide library districts.

Sedro-Woolley Liberian Debra Peterson explained that she was asked to provide an estimate of what a new library district would need to get started. She indicated the dollar amount that she estimated would be \$866,921, which was based on \$0.50 per 1,000 for that district. She went on to describe the services the library district could offer.

There was a brief discussion about the potential of a reciprocal agreement with the City of Sedro-Woolley and rural partial county library district if the district were formed.

Commissioner Dillon made a motion to make a decision on this matter on Tuesday, September 11, 2012, at 10:00 a.m. in the Commissioners' Hearing Room. Commissioner Wesen seconded the motion, which passed unanimously.

Chairman Dahlstedt recessed the proceedings at 11:29 a.m.

b) 11:30 a.m. - 11:45 a.m. Public Comment Period

Chairman Dahlstedt reconvened the proceedings at 11:33 a.m.

Carol Ehlers of West Fidalgo Island provided the Commissioners with a memorandum that she had provided to Senior Planner Betsy Stevenson, dated July 24, 2012, regarding essential County documents to use in the Shoreline Master Plan benchmarking "no net loss". She mentioned that the County should refer to the May 18, 1995 Nookachamps Watershed Nonpoint Action Plan; the November 1993 Lower Skagit River Basin Water Quality Study, Final Report; May 30, 1995 Padilla Bay/Bay View Watershed Nonpoint Action Plan, the December 1995 Samish Bay Watershed Nonpoint Action Plan, and the December 2002 Growth Management Indicators Report. Ms. Ehlers stressed the importance of the County referencing and utilizing historical documents before any new reports are created.

Chairman Dahlstedt recessed the proceedings at 11:47 a.m.

Total compensation remains unchanged at an amount not to exceed \$167,000. All other terms and conditions of the original contract shall remain in effect. (Amendment No. A20120111)

Interlocal Cooperative Agreement with the Swinomish Indian Tribal Community to provide a secure and accessible site for placement of a County election ballot drop box on property for voters of Skagit County to deposit ballots during elections. - 7. Resolution to terminate the appointment of Warren Angel to serve as a Designated Mental Health Professional (DMHP) and Designated Crisis Responder (DCR) effective immediately. Warren Angel is no longer employed as a DMHP or DCR with Compass Health, the certified provider of mental health emergency services in Skagit County. (**Resolution No. R20120283**)
- 8. Resolution to terminate the appointment of Michael Rattray to serve as a Designated Mental Health Professional (DMHP) and Designated Crisis Responder (DCR) effective immediately. Michael Rattray is no longer employed as a DMHP or DCR with Compass Health, the certified provider of mental health emergency services in Skagit County. (Resolution No. R20120284)
- 9. Resolution to terminate the appointment of Malcolm River to serve as a Designated Mental Health

Professional (DMHP) and Designated Crisis Responder (DCR) effective immediately. Malcolm River is no longer employed as a DMHP or DCR with Compass Health, the certified provider of mental health emergency services in Skagit County. (**Resolution No. R20120285**)

- 10. Resolution to terminate the appointment of Billie Risa Draves to serve as a Designated Mental Health Professional (DMHP) and Designated Crisis Responder (DCR) effective immediately. Billie Risa Draves is no longer employed as a DMHP or DCR with Compass Health, the certified provider of mental health emergency services in Skagit County. (Resolution No. R20120286)
- 11. Resolution to terminate the appointment of Rebecca Griswold to serve as a Designated Mental Health Professional (DMHP) and Designated Crisis Responder (DCR) effective immediately. Rebecca Griswold is no longer employed as a DMHP or DCR with Compass Health, the certified provider of mental health emergency services in Skagit County. (**Resolution No. R20120287**)
- 12. Resolution authorizing the appointment of members to the Skagit County Treatment Sales Tax Allocation Advisory Committee. (**Resolution No. R20120288**)

- 14. Personal Services Agreement with Skagit Recovery Center to provide treatment activities to eligible individuals in the Residential Substance Abuse Treatment (RSAT) program. The Agreement shall commence on October 1, 2012, and continue until September 30, 2013. Compensation shall not exceed \$240,000 and is funded by 0.1% sales tax. (Contract No. C20120368)
- 15. Interlocal Cooperative Agreement with North Sound Mental Health Administration (NSMHA) to provide funds to NSMHA to match a State grant that will provide High Fidelity Wraparound Mental Health Services to children and their families in Skagit County. The Agreement shall commence on the date of execution and continue through June 30, 2013. Compensation shall not exceed \$36,000. (Contract No. C20120369)

Resolution to receive the full payment amount as entitled to eligible counties under Public Law PL 106-393 and the distribution of these project funds for expenditure between projects in accordance with Title II and Title III of PL 106-393; to distribute 8% of the 15% of the projects funds to Title II and 7% of the 15% of the project funds to Title III projects. (**Resolution No. R20120289**)
- 17. Amendment No. 2 to Personal Services Agreement No. C20100510 with Northwest Real Estate Valuation, LLC, to perform property evaluations, review appraisals, and provide full appraisals for the Farmland Legacy Program, Salmon Recovery Program, and Drainage Utility Projects, and to provide Farmland Legacy Program pricing formula. The Agreement commenced on January 1, 2011, and continues until December 31, 2012. The purpose of this Amendment is to increase compensation by \$15,000 for a new compensation amount not to exceed \$90,000. All other terms and conditions of the original Agreement and subsequent Amendment shall remain in effect. (Amendment No. A20120113)

g) HEALTH:

18. Resolution authorizing the waiver of the office visit portion of the Tetanus, Diphtheria, and Pertussis (Tdap) fee due to the current whooping cough epidemic. The resolution shall be effective on the date of execution and expire on December 31, 2012. **(Resolution No. R20120290)**

19. Amendment No. 2 to Personal Services Agreement No. C20110630 with Summit Law Group to provide legal assistance pertaining to labor matters. The original Agreement commenced on December 31, 2011, and shall continue until December 31, 2012. The purpose of this Amendment is to increase compensation by \$47,000 for new compensation amount not exceed \$87,000. All other terms and conditions of the Agreement and subsequent Amendment shall remain in effect. (Amendment No. A20120114)

i) PLANNING AND DEVELOPMENT SERVICES:

- Quit Claim Deed by Gilbertson Land Company, LLC to Skagit County to convey the land transfer on Parcel No. P18117 to authorize it to become part of Parcel P18093 located in Skagit County. There is no monetary consideration being paid. (Contract No. C20120370)
- 21. Interlocal Cooperative Agreement with the City of Burlington to perform tasks associated with Burlington Commercial Core Redevelopment Analysis, Phase 2 of the transfer of development rights project. The Agreement shall commence on the date of execution and continue until December 31, 2014. Compensation to Skagit County shall not exceed \$50,000 and is funded by a grant from the Washington State Department of Commerce. (Contract No. C20120371)
