

**RECORD OF THE PROCEEDINGS
SKAGIT COUNTY BOARD OF COMMISSIONERS
MONDAY, DECEMBER 23, 2013**

The Skagit County Board of Commissioners met in regular session on Monday, December 23, 2013, with Chair Sharon D. Dillon, and Commissioner Ron Wesen present. Commissioner Kenneth A. Dahlstedt excused.

I. CALL TO ORDER:

Chair Dillon called the proceedings to order at 12:59 p.m. and excused Commissioner Dahlstedt's absence.

II. PLEDGE OF ALLEGIANCE:

Chair Dillon led the gallery in the salute to the flag.

III. AGENDA:

a) *8:30 a.m. - 10:30 a.m. Briefing - County Commissioners/County Administrator

b) 1:00 p.m. - 1:15 p.m. Sheriff's Office - Will Reichardt, Sheriff:

1. Presentation: Community Integration Program

Sheriff Will Reichardt and Corrections Deputy Julie Zorn were present in the gallery to answer questions.

Charlie Wend, Chief Corrections Deputy, updated the Commissioners on the Community Integration Program (CIP). He indicated that the program was a partnership between the Skagit County Sheriff's Office; Skagit County Community Services, Community Action Agency of Skagit County; Skagit Valley College; and the Washington State Department of Corrections. Deputy Wend said that the project grew from a need to combat recidivism rates. He indicated that in Skagit County Jail, the recidivism rate was sixty (60) to seventy (70) percent. He said that by introducing education and vocational training, the number of people that return to jail was expected to drop significantly. He mentioned that housing was an integral part that helped to lead to the successful reintegration of ex-offenders.

Deputy Wend mentioned that Senator Kirk Pearson, and Representative Kristine Lytton were strong supporters of the CIP. He said that by the end of January 2014, a small group from Skagit County would be traveling to Olympia to present the program and ask for funding. He said that once a date had been set, he would invite the Commissioners to attend if they were available.

Sinead Fitzpatrick Plagge, Skagit Valley College Associate Dean for Workforce Education, said that the Skagit Valley College Community Integration Project (CIP) Program started about five (5) years ago and was designed to support and help previously incarcerated individuals who were interested in further education. Ms. Fitzpatrick Plagge spoke about the array of programs connected with the CIP. She noted that one of the main reasons students who were enrolled in the program could not continue was that they lacked safe and reliable housing accommodations.

Commissioners Dillon and Wesen spoke in support of the program and the partnerships.

c) 1:15 p.m. - 1:30 p.m. Budget and Finance - Trisha Logue, Director:

Trisha Logue, Budget and Finance Director, stated that the amendment was necessary in order to allow for year-end expenses to be processed prior to January 2014. Ms. Logue provided a listing of the amendments.

1. Public Hearing to Consider Testimony Regarding Amending the 2013 Skagit County Budget

Chair Dillon opened the public hearing at 1:28 p.m.

Seeing no public testimony forthcoming, Commissioner Wesen made a motion to close the public hearing at 1:29 p.m., Chair Dillon seconded the motion which passed unanimously.

A motion was made by Commissioner Wesen to approve a Resolution amending the 2013 budget as outlined by the Budget and Finance Director. **(Resolution No. R20130397)** Commissioner Wesen seconded the motion.

The vote passed unanimously. Commissioner Kenneth A. Dahlstedt's absence was excused

- 2. Personal Services Agreement with Robert K. Weidner to serve as the Washington, D.C. government relations advisor for Skagit County and other counties of the Evergreen Forest County Group. The Agreement shall commence on January 1, 2014, and continue December 31, 2014. Compensation shall not exceed \$10,000. **(Contract No. C20130541)**

c) COMMUNITY SERVICES:

- 3. Personal Services Agreement with Northwest Youth Services to distribute Homeless Housing Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Northwest Youth Services will operate the Skagit County Transitional Living, providing at least fourteen (14) housing units to homeless and runaway youth aged 16 to 21 years. In addition to housing, Northwest Youth Services will provide program participants with housing, case management, vocational support services, mental health treatment, drug and alcohol services, and transportation assistance. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$35,000. **(Contract No. C20130542)**
- 4. Personal Services Agreement with Anacortes Family Center to distribute Homeless Housing and Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Anacortes Family Center will provide shelter and basic needs to an estimated five hundred (500) to six hundred (600) individuals. The interim housing program will provide up to sixty (60) bed nights of housing for over one hundred and twenty (120) individuals. In addition housing, Anacortes Family Center will provide intensive interim housing program clients with wrap-around case management and life skills education services. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$53,010. **(Contract No. C20130543)**
- 5. Personal Services Agreement with Phoenix Recovery Services to provide chemical dependency services to individuals enrolled in Skagit County Family Treatment Court. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$25,000 and is funded by the .1% sales tax. **(Contract No. C20130544)**
- 6. Personal Services Agreement with Phoenix Recovery Services to provide recovery support

services to enrolled WA-CARES program eligible clients. The Agreement shall commence on January 1, 2014, and continue until September 30, 2014. Compensation shall not exceed \$30,051 and is funded by the Substance Abuse and Mental Health Services Administration, Center for Substance Abuse Treatment. **(Contract No. C20130545)**

7. Personal Services Agreement with Island Hospital to provide mental health services with the primary goals of stabilization of problematic symptoms and/or behaviors and the promotion of ongoing recovery. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$20,000. **(Contract No. C20130546)**
8. Personal Services Agreement with Skagit Habitat for Humanity to distribute low-income housing funds pursuant to House Bill 2060. Funding will be used to reimburse Skagit Habitat for Humanity for the costs resulting from the purchase of building rights for a buildable lot in Channel Cove in La Conner. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$25,000. **(Contract No. C20130547)**
9. Personal Services Agreement with Phoenix Recovery Services to provide chemical dependency treatment services for individuals observing or enrolled in Drug Court and DUI Court. The Agreement shall commence on January 1, 2014, and continue until September 30, 2014. Compensation shall not exceed \$150,000 and is funded by a Bureau of Justice Assistance Grant. **(Contract No. C20130548)**
10. Amendment No. 2 to Personal Services Agreement No. C20120544 with Phoenix Recovery Services to provide urinalysis testing for Mental Health Court participants. The original Agreement commenced on January 1, 2013, the purpose of this Amendment is to extend the term of the Agreement from December 31, 2013, to June 30, 2014. This Amendment increases compensation by \$11,000 for a new compensation amount not to exceed \$63,000 which is funded by the .1% sales tax. All other terms and conditions of the original Agreement and subsequent Amendment shall remain in effect. **(Amendment No. A20130157)**
11. Personal Services Agreement with Community Action of Skagit County to distribute Homeless Housing and Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Skagit County Community Action Agency will provide shelter and transitional housing at ten (10) fully furnished apartments at the William J. Shuler Family Development Center. During 2014, an estimated fifty-nine (59) homeless families will be served through shelter services and twenty (20) to thirty (30) families each month will be served through transitional housing. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$209,653. **(Contract No. C20130549)**
12. Personal Services Agreement with Shifa Health, PLLC to provide mental health services with the primary goals of stabilization of problematic symptoms and/or behaviors, and the promotion of ongoing recovery. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$30,000 and is funded by the .1% sales tax. **(Contract No. C20130550)**
13. Personal Services Agreement with Community Action of Skagit County to distribute Homeless Housing and Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Community Action of Skagit County will collaboratively implement with a variety of community stakeholders, and resources, to coordinate the Project Homeless Connect event which is based on the national model in which individuals and families facing homelessness are offered an array of same-day services at one location from a variety of providers. Project Homeless Connect will serve approximately three-hundred and fifty (350) to four hundred (400) people, representing seven-hundred (700) to eight-hundred and fifty (850) household members at its 2014 event. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$5,000. **(Contract No. C20130551)**
14. Personal Services Agreement with Home Trust of Skagit to distribute low-income housing funds pursuant to House Bill 2060 to provide subsidies for two (2) or more low-income families. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$65,000. **(Contract No. C20130552)**

15. Personal Services Agreement with People First to provide self-advocacy, leadership development, and recreational opportunities for individuals with development disabilities and their family members. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$5,300 and is funded Developmental Disability Millage funds. **(Contract No. C20130553)**
16. Amendment No. 1 to Personal Services Agreement No. C20120568 with Compass Health to provide integrated mental health and chemical dependency treatment services for up to twenty (20) Skagit county Mental Health Court clients. The original Agreement commenced on January 1, 2013, the purpose of this Amendment is to extend the term of the Agreement from December 31, 2013, to June 30, 2014. This Amendment revises Exhibit "B" Scope of Work and increases compensation by \$20,000 for new compensation amount not to exceed \$115,000. All other terms and conditions of the original Agreement shall remain in effect. **(Amendment No. A20130158)**
17. Personal Services Agreement with Pioneer Human Services to manage the sixteen (16) bed, adult, voluntary Skagit County Crisis Center to provide integrated state-certified sub-acute detoxification and mental health crisis stabilization services. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$566,592 and is funded by the .1% sales tax. **(Contract No. C20130554)**
18. Personal Services Agreement with Phoenix Recovery Services to provide urinalysis testing and mental health services to individuals referred for participation in Skagit County's Adult Felony Drug Court. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$40,000. **(Contract No. C20130555)**
19. Personal Services Agreement with Pioneer Human Services to provide the services and staff necessary for or incidental to the performance of the Residential Substance Abuse Treatment (RSAT) program. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$340,000 and is funded by the .1% sales tax. **(Contract No. C20130556)**
20. Personal Services Agreement with Paul Douhan to provide mental health services with the primary goals of stabilization of problematic symptoms and/or behaviors and the promotion of ongoing recovery. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$10,000. **(Contract No. C20130557)**
21. Personal Services Agreement with Compass Health to distribute Homeless Housing and Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Compass Health will operate its Housing Assistance Voucher program by providing housing vouchers to serve approximately one-hundred and ten (110) eligible low-income tenants. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$46,345. **(Contract No. C20130558)**
22. Personal Services Agreement with Skagit Valley Hospitality Association dba Friendship House to distribute Homeless Housing and Assistance funds pursuant to Substitute House Bill 2163 and House Bill 2331. Friendship House will operate a men's shelter, women's shelter and two (2) transitional living houses, seven (7) days per week, three-hundred and sixty-five (365) days for the year 2014. Friendship House will provide local homeless and individuals, and women with children with shelter, basic needs, assessment and referral to community resources to approximately seven-hundred (700) individuals. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$75,000. **(Contract No. C20130559)**
23. Personal Services Agreement with United General Hospital to provide enhanced funding from the Partnership for Success (PFS) grant award for substance abuse prevention programs and services to high-need communities currently receiving funding to implement the Community Prevention and Wellness Initiative (CPWI). The Agreement shall commence on the date of execution and continue until September 30, 2014. Compensation shall not exceed \$29,662 and is funded by the PFS grant award. **(Contract No. C20130560)**

24. Interlocal Cooperative Agreement with Northwest Educational Service District 189 to provide behavioral health intervention and treatment services for children in grades K-8 in all seven (7) school districts in Skagit County. The services will be community-based, school-connected, culturally competent, developmentally appropriate and accessible to families. The Agreement shall commence on January 1, 2014, and continue until August 31, 2014. Compensation shall not exceed \$400,333 and is funded by the .1% sales tax. **(Contract No. C20130561)**
 25. Personal Services Agreement with Sea Mar Community Health to provide mental health services with the primary goals of stabilization of problematic symptoms and/or behaviors and the promotion of ongoing recovery. The Agreement shall commence on January 1, 2014, and continue until December 31, 2014. Compensation shall not exceed \$20,000 and is funded by the .1% sales tax. **(Contract No. C20130562)**

28. Personal Services Agreement with David Lowrance to provide audio-visual production services for both in-house for Skagit County and on location for Skagit 21. The Agreement shall commence on the date of execution and continue until December 31, 2014. Compensation shall not exceed \$40,000. **(Contract No. C20130563)**
 29. Addendum No. 1 to Dark Fiber Optic Lease Agreement No. C20120063 with Black Rock Cable to install fiber lines. The purpose of this Addendum is to provide a fiber license for one (1) single mode fiber between Skagit County and the Anacortes Police Department for access to the County Spillman system. The term for this connection will be for one (1) year and shall thereafter be on a month-to-month basis. Compensation for this Addendum shall not exceed \$392 per month or \$4,704 per year for a new compensation amount not to exceed \$35,844, plus applicable fees, utility taxes and other taxes. All other terms and conditions of the original Agreement shall remain in effect. **(Amendment No. A20130159)**
 30. Product Support & Enhancement Agreement with Xerox Government Systems, LLC for the Skagit County Superior Court Jury Data Merge and Component System Manager Maintenance. Xerox, as the successor in interest to Omni-Tech Systems Ltd, shall continue to provide the services that were previously provided by Omni-Tech Systems Ltd. The Agreement shall commence on the date of execution, has an initial yearly support cost of \$7,882 and is non-terminating. **(Contract No. C20130564)**

31. Personal Services Agreement with The Drain Doctor to provide operation and maintenance for the Edison sub-area large on-site septic collection and treatment system. The Agreement shall commence on January 1, 2014, and continue until December 31, 2015. Compensation for the first year shall not exceed \$10,855.20 and \$11,180.86 for the second year for routine work. Work done after hours, weekends or holidays shall be billed at \$49 to \$79.50 per hour. The Agreement shall commence on the date of execution and continue until December 31, 2016. Compensation shall not exceed \$59,000 for the three (3) year period. **(Contract No. C20130572)**
40. Amendment No. 1 to Communications Site Lease Agreement for the Rockport Solid Waste Site, Contract No. 004862 with the Washington State Department of Transportation. The original Agreement commenced on December 1, 1999, and continues until December 1, 2024, with the right to apply for renewal for an additional twenty-five (25) year period. The purpose of this Amendment is to amend the "Section V - Improvements, Facilities, and Equipment" portion of the original Agreement in order to allow the Washington State Department of Transportation and the Washington State Patrol to alter existing radio facilities. All other terms and conditions of the original shall remain in effect. **(Amendment No. A20130160)**
41. Amendment No. 2 to Personal Services Agreement No. C20120143 with The Watershed Company to assist with culvert replacements for the benefit of fish passage. The original Agreement commenced on April 9, 2012, the purpose of this Amendment is to extend the term of the Agreement from December 31, 2013, to March 31, 2014 to allow for adequate time to complete culvert designs. All other terms and conditions of the original Agreement and subsequent Amendment shall remain in effect including the total compensation amount not to exceed 98,840 which is funded 33 1/3% by Clean Water funds; 33 1/3% by Drainage funds; and 33 1/3% by Public Works Road funds. **(Amendment No. A20130161)**
