RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS TUESDAY, JUNE 2, 2015

The Skagit County Board of Commissioners met in regular session on Tuesday, June 2, 2015, with Chair Kenneth A. Dahlstedt, Commissioner Lisa Janicki, and Commissioner Ron Wesen present.

I. CALL TO ORDER

Chair Dahlstedt called the proceedings to order at 9:31 a.m.

II. PLEDGE OF ALLEGIANCE:

Chair Dahlstedt led the gallery in the salute to the flag.

III. AGENDA:

a) 9:30 a.m. - 10:00 a.m. Presentation from Northwest Innovation Resource Center

Interim Executive Director Diane Kamionka of NW Innovation Resource Center (NWIRC) briefed the Commissioners on the services they provided to innovators, inventors and entrepreneurs to get their products and ideas to market. She said that NWIRC was created in 2011 as a 501c3 non-profit to support innovation in the northwest and to keep local talent from having to relocate to Seattle or California where similar services are traditionally found.

Ms. Kamionka shared how NWIRC assisted innovators, inventors and entrepreneurs by helping them with their strategy, providing tools about how to accomplish a particular task, and connecting them to others in the community who would be able to help them succeed.

Commissioner Janicki commented on NWIRC's Board of Directors and was impressed by the areas of expertise and leadership the Board provided NWIRC. She asked how NWIRC was funded.

Ms. Kamionka said that the NWIRC Board was very active in the community and that it was going to be expanding to include members from Skagit and Snohomish Counties. Ms. Kamionka said that NWIRC was funded through a variety of public and private funding opportunities.

The Commissioners thanked Ms. Kamionka for sharing information about NWIRC. Chair Dahlstedt suggested Ms. Kamionka contact Kevin Murphy at Skagit Council of Governments to see if any funding opportunities would be available through any of their programs.

b) 10:00 a.m. - 10:30 a.m. Presentation from Northwest Youth Services Regarding Strategic Plan to End Homelessness

Chair Dahlstedt reconvened the proceedings at 10:00 a.m. and introduced Executive Director of Northwest Youth Services Riannon Bardsley.

Ms. Bardsley briefed the Commissioners on the support services and programs offered to homeless youth at Northwest Youth Services. She said annual counts of homeless youth were taken once a year in each county and that Skagit County counted 98 youths. Ms. Bardsley said a more accurate count would be just under 300. She said that some of their partners included Community Action of Skagit County and United Way which helped them provide shelter and other services.

Ms. Bardsley said that Northwest Youth Services provided 18 beds to youth. Another shelter, Oasis Teen Shelter which is part of YMCA, offered 8 beds. She said that the reasons behind youth homelessness were multi-faceted and often involved fleeing a domestic violence situation, gang involvement, and mental illness. She also shared that one in four youth who age out of foster care in Washington end up homeless within a year and that the system was failing our youth.

Ms. Bardsley encouraged community involvement and volunteerism to mentor local youth and change their lives. The Commissioners echoed the need for the local community to step forward towards providing the resources needed to effect change and stability in young people's lives.
