## RECORD OF THE PROCEEDINGS SKAGIT COUNTY BOARD OF COMMISSIONERS MONDAY, DECEMBER 7, 2015

The Skagit County Board of Commissioners met in regular session on Monday, December 7, 2015, with Chair Kenneth A. Dahlstedt, Commissioner Lisa Janicki, and Commissioner Ron Wesen present.

## I. CALL TO ORDER:

Chair Dahlstedt called the proceedings to order at 1:30 p.m.

Chair Dahlstedt led the gallery in the salute to the flag.

Chair Dahlstedt reconvened the proceedings at 2:32 p.m.

1. Public Hearing to Consider Testimony Regarding the 2016 Skagit County Budget and 2016 Tax Levies

Budget and Finance Director Trisha Logue provided a PowerPoint presentation and an overview of the 2016 budget process.

Ms. Logue reported on the revenues and expenses for the General Fund and pointed out that in addition to the General Fund there were 49 other funds. Ms. Logue said that the largest source of revenue for he General Fund was property taxes.

Ms. Logue provided a history of the County's staffing levels and noted that the 2016 proposed budget included adding 17.83 full-time positions.

The final budget and levy adoption was tentatively scheduled to take place on Monday, December 14, 2015, at 2:30 p.m., in the Commissioners' Hearing Room.

Chair Dahlstedt opened the public hearing at 2:50 p.m.

Manager of the Skagit Conservation District Carolyn Kelly commented on the District's request for an increase in funding from the Clean Water District fund and expressed disappointment that the requested funds were not included in the proposed 2016 budget. Ms. Kelly requested that the Board reconsider their request.

Carol Ehlers of West Fidalgo Island commented on the increase in the Clean Water assessment. Ms. Ehlers expressed disappointment that Planning Commission meetings may no longer be transcribed; the need to notify the Group A and B water systems that a Coordinated Water Systems Overlay Map had been created; and that senior citizens were not included in the Population Health Trust's Quality of Life Survey.

Wendy Parr of Edison and a Supervisor on the Skagit Conservation District Board provided information about the volunteer program and the work that they provide. Ms. Parr noted that the District paid \$25,000 to the Department of Ecology to use the lab at Padilla Bay.

Robert Parr of Edison and Marine Biotoxin and Stream Storm Team and Stream Team commented on the work that volunteers provide and that the volunteers provided stream sampling services when County staff were not available which benefited the shellfish farmers and spoke in favor of increasing funding to the Skagit Conservation District.

Skagit County Prosecuting Attorney Rich Weyrich spoke in favor of the reclassification of Chief Civil Deputy Prosecuting Attorney Melinda Miller; renewal special stipend for Chief Criminal Deputy Prosecuting Attorney Erik Pedersen; increasing compensation for Forensic Interviewer Debra Ridgway; promotion Deputy Prosecuting Attorney Russell Brown to Senior Deputy Prosecuting Attorney; and that the Commissioners grant several other requests that were submitted during the budget process.

Seeing no further public testimony forthcoming, Commissioner Wesen made a motion to close the public hearing at 3:18 p.m., Commissioner Janicki seconded the motion which passed unanimously.

The Commissioners agreed to receive written public comments until Wednesday, December 9, 2015, at 4:30 p.m.

Coroner Daniel Dempsey provided additional information about Consent Agenda item #4.

County Administrator Tim Holloran provided additional information about Miscellaneous Agenda items #1 and #2 and noted that on May 1, 2007, the Washington State Legislature passed House Bill 1543 which allowed public facility monies to be used to pay for personnel in economic development offices. He said that the Public Facilities Committee met on November 23, 2015, to evaluate and discuss the 14 applications that were submitted for funding and that the Committee had endorsed 7 public facility projects and funding for personnel at the Economic Development Association of Skagit County (EDASC). Mr. Holloran provided information about the fiber optic requests that were not funded and noted that the Committee's suggestion was to wait until the spring to review the fiber optic projects.

Information Services Coordinator Mike Almvig provided additional information about the City of Anacortes' request for fiber optic funding and said that once the fiber optic consortium reconvened, they would review the applications for fiber optic expansion funding.

Economic Development Association of Skagit County (EDASC) Executive Director John Sternlicht provided additional information about EDASC funding and reported that EDASC would change the structure of their private sector membership in order to provide them with a more sustainable funding mechanism.

City of Mount Vernon Mayor Jill Boudreau expressed the City's appreciation of the Committee's recommendation to approve funding for the Flood Wall project.

City of Sedro-Woolley Public Works Director Mark Freiberger expressed appreciation of the Committee's recommendation to approve funding for the Route 20/Cascade Trail West Extension - \$220,000, and noted that it would help to address some stormwater concerns and would help with economic development in the area.

Mayor of the Town of Concrete Jason Miller expressed appreciation and said that the funding would allow the Town to build restrooms which was a requirement for the spray park.

Washington State University Bread Lab Program Coordinator Wendy Hebb expressed their appreciation and extended an invitation for the Commissioners to visit the facility.

Water Resource Section Manager Mike See provided additional information about Consent Agenda item #55.

Emergency Medical Services Director Mark Raaka provided additional information about Miscellaneous Agenda item #3.
