

**RECORD OF THE PROCEEDINGS
SKAGIT COUNTY BOARD OF COMMISSIONERS
MONDAY, DECEMBER 5, 2016**

The Skagit County Board of Commissioners met in regular session on Monday, December 5, 2016, with Commissioner Ron Wesen, and Commissioner Kenneth A. Dahlstedt present. Chair Lisa Janicki excused.

I. CALL TO ORDER:

Commissioner Dahlstedt called the proceedings to order at 10:04 a.m.

II. PLEDGE OF ALLEGIANCE:

Commissioner Dahlstedt led the gallery in the salute to the flag.

III. AGENDA:

a) *8:30 a.m. - 9:30 a.m. Briefing - County Commissioners/County Administration with Public Works, Planning and Development Services, and Public Health

b) 10:00 a.m. - 11:00 a.m. Planning and Development Services - Dale Pernula, Director:

1. Public Hearing: To Consider Testimony Regarding the 2017 Comprehensive Plan, Map and Code Amendment Docket

Mr. Pernula reported that 15 public petitions and 21 county petitions had been submitted for consideration to add to the 2017 docket. A memo from Planning and Development Services regarding the public hearing and providing information on the docket can be found here:

Commissioner Dahlstedt provided an opening statement; limiting individual comments to 3 minutes in length in order to allow everyone present an opportunity to speak, and announced that the written comment period would remain open until Thursday, December 8, 2016, at 4:30 p.m.

Hal Rooks of Guemes Island and the Guemes Island Planning Advisory Committee (GIPAC) said that he believed most living on Guemes Island supported GIPAC's three proposed code amendments, that Planning and Development Services was considering removing two of the amendments from the docket in order to implement sooner on their work program, and that the amendments were meant to protect the water supply on Guemes Island, reduce the impacts of new development, and protect senior water rights.

Sally Stapp of Guemes Island supported the work of GIPAC and discussed the importance of water preservation and protection on Guemes Island. She also commented on P-7 and said that land designated as open space should remain in open space permanently.

Phyllis Bravinder of Guemes Island said she agreed with everything Sally Stapp said.

Michael Brown of Guemes Island and GIPAC discussed his support for rain water catchment on Guemes Island, and said that it would benefit other parts of the county too.

Jim Laurel of Fidalgo Island provided testimony in support of docketing P-12 and said that the current zoning allowed too many commercial uses which increased traffic, odors, and noise within the residential-like area.

Phyllis Woolworth of Forest Lane said she supported GIPAC's efforts to protect water on Guemes Island.

Brian Adams of Anacortes and Skagit County Parks and Recreation discussed C-1 and said that he believed Skagit County would be able to leverage grant funding for the installation of a boardwalk for Wiseman Creek.

Kathleen Jett of Anacortes supported docketing P-12, agreed with Mr. Laurel, and asked that South Fidalgo Island be zoned differently.

Roger Mitchell of Bow briefed the audience and Commissioners on the four proposals he submitted and encouraged supporters of his common-sense approaches to submit letters to the Commissioners.

Ron Hass of Bow said he was present on behalf of the property owners on Butler Hill and he expressed his support to docket PL15-0383 by Skagit Partners, LLC and said that it would help the educational system and economy.

Roger Robinson of South Fidalgo Island discussed P-12 and asked that it be docketed in order to discuss the creation of a new zone.

Randy and Aileen Good of Sedro-Woolley asked that P-2 and P-3 be docketed and provided testimony to also docket C-1 Wiseman Creek and C-2 Coast to Cascades.

Konrad Kurp of South Fidalgo Island shared that he had been a member of the South Fidalgo Planning Commission and he asked the Commissioners to protect the open space on Fidalgo Island and make a positive list of allowed uses.

Sheila Pritchett of Anacortes asked the Commissioners to docket P-12. She said that current zoning on South Fidalgo Island created conflict between neighbors and property owners.

Ellen Bynum of Friends of Skagit County provided testimony in support of docketing P-1, and against docketing PL15-0383 by Skagit Partners, LLC saying that it was not allowed by the Growth Management Act and did not match population projections.

Bob Carmichael, representing Skagit Partners, LLC provided testimony in support of docketing PL15-0383, saying that the Growth Management Act allowed the fully contained community and described the benefits that the new area would provide in Skagit County.

Roger Pearce of Anacortes asked the Commissioners to be careful about allowing large building developments in Skagit County and provided testimony in support of docketing P-12.

David Pearson of Anacortes shared that he worked on the South Fidalgo Subarea Plan many years ago and said that most of the ideas in their draft plan were well thought out and supported by the community. Mr. Pearson asked for the completion of the Subarea Plan, or, at the very least to docket P-12.

Tom Glade of Evergreen Islands provided testimony in support of docketing P-1, P-5, P-6, P-7, and P-12, and he read from a 1994 letter sent by the Department of Ecology regarding elevated chloride levels found in the ground water and to limit new construction within certain areas of Fidalgo Island due to the seawater intrusion.

Tom Conroy of Anacortes provided testimony in support of docketing P-12.

Dave Coleburn of Anacortes provided testimony against docketing P-12 saying that it was not fair to change zoning on South Fidalgo Island and disrupt the businesses that were already located there.

Seeing no one else wishing to provide testimony, Commissioner Dahlstedt announced that the Commissioners were scheduled to make a decision on December 20, 2016, and he recessed the proceedings at 11:03 a.m.

d) 2:30 p.m. - 3:30 p.m. Budget and Finance - Trisha Logue, Director:

1. Public Hearing: To Consider Testimony Regarding Property Tax Levies and the Skagit County Budget for 2017

Commissioner Dahlstedt reconvened the proceedings at 2:30 p.m. and introduced Trisha Logue. Ms. Logue provided information to the Commissioners on the 2017 budget process and provided an overview of the funds. The PowerPoint provided by Ms. Logue can be found here:

Commissioner Dahlstedt opened the public hearing at 2:46 p.m.

Carol Ehlers of Fidalgo Island provided testimony regarding possible lost taxes by Skagit County and the Anacortes School District on a portion of Fidalgo Island and to not let the tax shift occur, she said that the county's recent Capital Facilities Plan was great, but was disappointed to see the Salvation Army building would not be used for records storage since it was up for sale. She discussed the county's records policy.

Commissioner Wesen commented on the American Lands Council and said that Skagit County was not funding their membership to it this year.

Commissioner Dahlstedt said that they would work to balance the budget and he recessed the proceedings at 2:57 p.m.

e) 3:30 p.m. - 4:00 p.m. Budget and Finance - Trisha Logue, Director:

1. Public Hearing: To Consider Testimony Regarding the Central Valley Ambulance Authority's Budget for 2017

Commissioner Dahlstedt reconvened the proceedings at 3:31 p.m. and introduced Bryan Harrison, current Chair of the Central Valley Ambulance Authority (CVAA). Mr. Harrison provided information regarding the proposed CVAA budget for 2017 which was more than the county had budgeted for.

Commissioner Dahlstedt opened the public hearing at 3:42 p.m. Seeing no one present to provide testimony, Commissioner Wesen made a motion to close the public hearing which was seconded by Commissioner Dahlstedt. The vote passed unanimously.

Further discussion was held regarding CVAA's proposed budget and working to analyzing the data to meet needs. Skagit County Administrator Tim Holloran thanked CVAA for their work and Interim EMS Director Kevin Chao for his leadership. Mr. Holloran said that Skagit County would meet with CVAA further to discuss their budget.

Parks, Recreation and Fair Director Brian Adams provided additional information on Consent Agenda item no. 18. Developmental Disabilities Program Coordinator Brian Carlson with Public Health provided additional information on Consent Agenda item no. 41.

Personal Services Agreement with Snohomish County Public Defender Association to provide consultation and representation for cases considered to be conflict of interest cases for the Skagit County Public Defender's Office and that have been determined to be within the scope of indigent defense. Case referrals will be from Skagit County Superior Court. The Agreement shall commence on January 1, 2017, and continue until December 31, 2017. Compensation shall not exceed \$147,600 for 60 cases per year and is based on a rate schedule, and, any extraordinary cost performed under this Agreement shall be approved in advance by the Assigned Counsel Director in an amount not to exceed \$10,000 yearly without order from the court. **(Contract No. C20160491)**
5. Personal Services Agreement with Wendy Wall, Attorney at Law, to provide consultation and representation for cases considered to be conflict of interest cases for the Skagit County Public Defender's Office and that have been determined to be within the scope of indigent defense. Compensation shall not exceed up to \$2,058 per month to Snohomish County. **(item pulled and to be considered at later date)**

Amendment No. 3 to Personal Services Agreement No. C20140528 with Dr. Justin Curran to backup and work under the direction of the Skagit Emergency Medical Program Director to provide medical control and direction to all persons that are involved in patient care and transport in the pre-hospital emergency care system within Skagit County. The purpose of Amendment is to update Exhibit B, Compensation, to allow for one monthly payment in the amount of \$4,500 to provide reimbursement for medical malpractice insurance, and, to provide monthly compensation in the amount of \$2,000 for services performed. All other terms and conditions of the original Agreement and subsequent Amendments shall remain in effect including the termination of December 31, 2018. **(Amendment No. A20160161)**
