Compensation shall not exceed \$10,000 and is based on a reimbursement schedule. The Agreement is ratified to commence on July 1, 2020, and continue until December 31, 2020. (Contract No. C20200582)
 - 23. Memorandum of Understanding with Habitat for Humanity in Whatcom County regarding affordable housing assistance through the Community Development Block Grant (CDBG) eligible Homeownership Assistance Project as funded by a grant in the amount of \$750,000 from the United

States Department of Housing and Urban Development (HUD) and administered by the Washington State Department of Commerce (Commerce). The County shall provide assistance in the form of homeownership assistance provided directly by check submitted to eligible homebuyers escrow accounts. Amendment No. 1 to Memorandum of Understanding (MOU) No. C20200376 between the Skagit County Sheriff's Office and Compass Health's Mobile Crisis Outreach Team (MCOT) to facilitate the coordination of services for individuals suffering from mental illness, substance use disorder who are in a behavioral health crisis and who are served by both organizations. This Amendment provides reimbursement to Compass Health for costs related to the MCOT program. Compensation shall not exceed \$4,000.
