- 14. Memorandum of Understanding with Skagit Legal Aid to assist Skagit County residents complete applications for the Treasurer Rent Assistance Program (T-RAP). The Agreement shall commence on the date of execution and continue through September 30, 2025. No compensation is associated with this Agreement. (Contract No. C20210460)
- 15. Memorandum of Understanding with Housing Authority of Skagit County and Community Action of Skagit County to coordinate the administration of the Housing and Urban Development (HUD) Emergency Housing Voucher (EHV) Program, assist individuals and families who are most in need, and determine the best use of the vouchers as well as other resources in the community. The Agreement shall commence on the date of execution and continue until terminated. No compensation is associated with this Agreement. (Contract No. C20210461)

Personal Services Agreement with Communities in Schools Whatcom-Skagit to provide an evidence-based program to support low-and-moderate-income families, households that have been disproportionately impacted by COVID-19, and those whose academic achievement or low school attendance signals that they have obstacles that prevent them from succeeding in schools. The Agreement is ratified to commence on September 1, 2021, and shall continue through August 31, 2022. Compensation shall not exceed \$500,000 and is funded by the American Rescue Plan Act. Amendment No. 1 to Personal Services Agreement No. C20200687 with Catholic Community Services of Western Washington to provide homeless outreach, case management, and shelter services according to the guidelines of Washington State Department of Commerce's most recent CARES Act Emergency Solutions Grant COVID-19 (ESG-CV) Guidelines as posted on the website. This Amendment decreases Shelter Operations by \$25,000 and increases Rapid Re-Housing by \$25,000. Compensation remains the same and shall not exceed \$1,382,888.16. The term remains the same and shall continue until September 30, 2022. All other terms and conditions of the original Agreement shall remain in effect. (Amendment No. A20210159)

3. MISCELLANEOUS AGENDA (items 1 and 2):

The Commissioners discussed Miscellaneous Agenda Item 1. Conversations had been held with staff and members of the public regarding the vacancies on the Planning Commission and it was recognized that it was important to clearly define and follow the process of appointing members to the Planning Commission. It was noted that usually no more than 1 or 2 applications were submitted when a vacancy occurred in a district due to the amount of time Planning Commission members needed to commit to meetings and reviewing material.

Each Commissioner had interviewed the two applicants who had applied for the position in District 1. Chair Janicki stated that the position in District 3 had only received one valid application to date and would remain open until additional applications were received. The process was that the Chair was required to choose from a list of 2 or more applicants.

Chair Janicki asked Commissioner Wesen who his preferred candidate was, wanting to consider his suggestion since vacancy was in his district.

After meeting with both applicants, and considering the amount of time already invested by Mr. Henley on the Planning Commission when he was appointed to fill a vacancy created when the previous member vacated the Commission before the term expired, Commissioner Wesen recommended the appointment of Vincent Henley.

Chair Janicki accepted the recommendation and moved to appoint Vincent Henley to fill the vacancy on the Skagit County Planning Commission in District 1.

A motion was made by Commissioner Wesen to approve that Vincent Henley fill the vacancy on Skagit County Planning Commission in District 1. Commissioner Browning seconded the motion.

The vote passed on a 2 - 1 vote with Commissioner Browning dissenting.

Watershed Planner Kara Symonds provided additional information on Miscellaneous Agenda Item 2. The Commissioners asked questions and Ms. Symonds provided answers and showed maps of the area depicting the movement of the river and continued erosion of the riverbank.

A motion was made by Commissioner Wesen to approve Miscellaneous Agenda Item 2. Commissioner Browning seconded the motion.

The vote passed unanimously.

The purpose of this Agreement is to finish work to acquire four (4) properties in Lyman, demolish all structures on these properties and complete site restoration for each property in accordance with the Open Space requirements set forth in 44 Code of Federal Regulations (CFR) Part 80. All acquired properties will be deed-restricted to ensure they remain as Open Space in perpetuity, in accordance with 44 CFR Part 80. Grant amount to Skagit County to complete Phase 1 shall not exceed \$67,687.50. The County match shall not exceed \$11,281.25. The Grant Agreement is ratified to commence on March 21, 2018, and end on March 15, 2023. (Contract No. C20210464)

g) <u>*2:30 p.m. - 3:30 p.m. Public Meeting to Consider Public Comments Regarding the Redistricting Process</u>

Chair Janicki reconvened the proceedings at 2:30 p.m. and introduced Skagit County Auditor Sandy Perkins.

Ms. Perkins introduced staff from FLO Analytics: Senior Analyst/Education Sector Lead Kent Martin, Communications Coordinator Abbi Russell, and GIS Analyst Rachel Roberts and staff from Skagit County: Elections Supervisor Gabrielle Clay, Elections Lead Lisa Lomsdalen, GIS Manager Geoff Almvig, GIS Technician Lead/Coordinator Sean Carson, and Communications Director Laura Han who were working to analyze population, geography, and communities of interest data to determine whether or not the boundaries of the districts in Skagit County needed to be adjusted.

Data from the U.S. Census showed the population in Skagit County had increased from 116,901 in 2010 to 129,523 in 2020 and that the growth occurred fairly equally throughout Skagit County.

Governments were required to redraw electoral district boundaries every ten years to ensure that population differences between districts was within 10%. In 2010, the population difference between the three districts was 2.2%. In 2020 the population difference between the districts was now 3.3%. If boundaries were redrawn they would need to take into consideration natural and municipal boundaries, demographics, and communities of interest.

Commissioner Wesen felt it would be important for each district to include agriculture.

Members of the public Stella Winberry and Paul Vance provided comments about redistricting and asked for additional information about the purpose of redistricting and whether the boundaries of the three Commissioner Districts were similar to other district boundaries in the County.
