Assistant Public Health Director Sarah Hinman introduced the agenda item and thanked veterans for their service. Mr. Diaz said that the Skagit County Veterans Assistance Program was operated by Skagit County Public Health, in partnership with Community Action of Skagit County Skagit Vets Connect Program. He said that Veterans Assistance Program supported veterans by providing transport to medical appointments and other emergency assistance services.
