Information pertaining to guilty plea and sentencing hearings:

Attorneys are being asked to contact the clerk ahead of time to schedule a disposition via video court.

For all video hearings, please make sure the clerk has been notified ahead of time if your client needs an interpreter. Dispositions with an interpreter must be held in person.

Guilty plea paperwork must be sent to the court **at least** 30 minutes prior to the hearing. Guilty plea paperwork should be e-mailed to districtcourt@co.skaqit.wa.us.

Skagit County District Court requires that the defendant be on location with their attorney for certain criminal video hearings. Sentence orders and other sentence documents originated by the court and signed by the Judge must be signed by the defendant during the hearing.

Sentence orders and other sentence documents originated by the court and signed by the Judge will be transmitted back to the attorney during the hearing for signature by e-mail. Once the paperwork is signed the attorney must scan and e-mail it back to the same e-mail address it was received from, which will be different each hearing depending on the court clerk.
