**INFORMATION REGARDING THE
INTERSTATE COMPACT FOR ADULT OFFENDER SUPERVISION
(ICAOS)**

APPLICABILITY:

YOU ARE REQUIRED TO OBTAIN PERMISSION BEFORE MOVING OUT OF STATE IF:

1. Your sentence includes at least one year of community supervision, with at least three months remaining; and
2. Any of the following applies to the crime of which you have been convicted:
 - a) Direct or threatened physical or psychological harm of a victim;
 - b) Use or possession of a firearm;
 - c) A second or subsequent misdemeanor DUI;
 - d) A sexual offense that requires registration.

ELIGIBILITY REQUIREMENTS:

IF YOU ARE REQUIRED TO OBTAIN PERMISSION BEFORE MOVING OUT OF STATE, PERMISSION MAY ONLY BE GRANTED IF ONE OF THE FOLLOWING APPLIES:

1. You are a resident of the state to which you wish to transfer (if you have lived in Washington over six months, you do not qualify).
2. You have family residing in the state to which you wish to transfer, AND employment or other means of support.
3. You are a member of the military or live with family who are in the military.
4. A member of your family has employment which has been transferred to the state to which you wish to transfer.

PROCEDURE:

IF YOU MEET THE ELIGIBILITY REQUIREMENTS LISTED ABOVE AND YOU WISH TO MOVE TO ANOTHER STATE YOU MUST DO THE FOLLOWING:

1. Comply with all court conditions of your sentence order (if you are not in substantial compliance, you will not be allowed to move).
2. Provide two money orders in the amount of \$60.00 made out to the Department of Corrections and one in the amount of \$40.00 made out to Skagit County District Court Probation.
3. Schedule an appointment with your Probation Officer, if you have one, to initiate the process. If you don't have one, our receptionist will schedule an appointment for you.
4. Once you initiate the transfer process, you must stay in the State of Washington until the request is approved or denied.

NOTE: If you are being supervised by more than one court, the general rule is that the jurisdiction (county) where you reside is the one that will initiate the request for you. If you are supervised by the Department of Corrections, they will handle the transfer request regardless of where you reside.
