## 2003 Plan Adoption

Early in the 2003 planning process, members of the Skagit Natural Hazards Mitigation Steering Committee met with the Board of Skagit County Commissioners, the Swinomish Indian Senate, Upper Skagit Tribal Council, and the Mayor of each municipality within the county to discuss the reasons and benefits for developing and adopting a multi-jurisdictional natural hazard mitigation plan.

Following these discussions, a Resolution for participating in a multi-jurisdiction natural hazard mitigation plan was prepared and presented for signature to each city/town council, the Swinomish Indian Senate, the Upper Skagit Tribal Council, the Board of Skagit County Commissioners, and Skagit County Dike District #12 via their regular agenda process.

Each of the above-referenced Indian Tribes and jurisdictions agreed to participate in the development of a multi-jurisdiction natural hazard mitigation plan by approving the resolution.

In addition to the above-listed resolutions, a cooperative Interlocal Agreement (Skagit County Contract C20030204) was signed by Skagit County Dike District #12, the City of Burlington and Skagit County for the purpose of developing this multi-jurisdictional plan to meet the requirements of the Disaster Mitigation Act of 2000.

The original **Skagit County Natural Hazards Mitigation Plan** was formally promulgated by signature of the Board of County Commissioners; Skagit County Dike District #12; Chairperson of the Swinomish Indian Senate; Chairperson of the Upper Skagit Tribal Council; and the mayors of Anacortes, Burlington, Concrete, Hamilton, La Conner, Lyman, Mount Vernon, and Sedro-Woolley on September 18, 2003.

As part of the plan adoption process, each city/town council, the Swinomish Indian Senate, the Upper Skagit Tribal Council, the Board of Skagit County Commissioners, and Skagit County Dike

District #12 signed resolutions formally adopting the **Skagit County Natural Hazards Mitigation Plan**.

## 2008 Plan Adoption

Upon receiving notice from FEMA that the updated plan was approved as a multi-jurisdictional local plan as outlined in 44 CFR Part 201 and approved as a Tribal Mitigation Plan as outlined in 44 CRF 201.7, the **Skagit County Natural Hazards Mitigation Plan** was adopted by each of the participating entities. Each city/town council, the Samish Indian Nation Tribal Council, the Swinomish Indian Senate, the Upper Skagit Tribal Council, the Board of Skagit County Commissioners, and Skagit County Dike District #12 signed resolutions formally re-adopting the updated **Skagit County Natural Hazards Mitigation Plan**. In addition, each participating special purpose district will sign resolutions formally re-adopting the updated plan.

A copy of FEMA's formal approval of the plan can be found on pages vi and vii, Section I of this plan. Electronic copies of all adopting resolutions from local Indian Tribes and jurisdictions were forwarded to FEMA Region X and the Washington State Hazard Mitigation Officer. Copies of all special purpose district adoption resolutions are maintained by the Skagit County Department of Emergency Management.
