Overview of the EMS Department: J. Pelonio & J. Sargent

- Fire-Based EMS Delivery Model
 - January 1st we moved from Central Valley Ambulance Authority to the Cities providing the Ambulance Transport Services
 - Mount Vernon was ALS
 - Sedro-Woolley became ALS
 - Burlington became ALS
 - Anacortes was ALS
 - Changing to this model removed tension and provided a clear command structure
 - More stability with new fire based system
- Training
 - Training Hub Model
 - If training is missed it can be made up with another Training Hub
 - Provided same equipment to the hubs
 - Curriculum is consistent
 - High School Training is done with the Training Hubs
 - Working on Law Enforcement Training
 - CPR/AED
 - Stop the Bleed
 - Internasal Narcan
 - Initial EMT Training:
 - Working on the Spring Course at Skagit Valley College
 - Extra education had been added
 - o Coroner
 - o Sim Lab
 - Ride time
 - Currently there's a waitlist for the Spring Students
 - Want to engage the agencies who will be receiving these students
 - Equipment that's used
 - Kit configuration
 - This Board will approve education
 - Currently only EMT level training provided
 - SVC would like to add EMR level training program
 - Application to add the EMR course
 - Applications for current EMT courses
- Criteria-Based Dispatch
 - Current calls a paramedic responds
 - o Other methodology's available based on questions asked by Dispatch
 - District 13 example
- Closest Unit Dispatch

- Sending closest appropriate unit to the call
- o Timeline supposed to be June of 2020
- o How many more BLS transport Provides should be added
 - Unknown until Criteria-Based is in place
- Representation for the North Regions EMS & Trauma Care Council
 - Openings available
 - o Recommendations over the special bylaw phone in meeting
