Agenda Review and Brief Business

The Steering Committee reviewed and approved the November 4, 2009 meeting summary.

Welcome from Skagit County Commissioner Chair, Sharon Dillon

- Commissioner Dillon welcomed the Steering Committee, County staff, and guests on behalf of the Board of Skagit County Commissioners and thanked all for their commitment and time to the Alternative Futures project.
- This is a unique opportunity which will affect our grandchildren's future and we are fortunate to have this opportunity: "If you don't dream and don't have a vision and let life go as status quo, then nothing changes. I believe a group such as you can make a difference."
- The Board of County Commissioners is committed to put into place what needs to done to move forward for Skagit County

<u>Presentation of Skagit Model Prototype – John Bolte</u>

Discussion of Next Steps

- Kirk Johnson discussed what will happen at the May 5th Steering Committee meeting. It could take a full three hours to review model assumptions. [no May meeting was held; instead this was done at the June 2 Steering Committee meeting.]
- Margaret Fleek mentioned that the Skagit River is not shown as a floodway per the FEMA map. She was concerned that the model would not show this information.
- John Lombard mentioned that the May and/or June meeting should possibly longer than three hours to get the work completed.
- Shirley Solomon inquired about the Citizens Committee.
- Rebecca Ponzio asked for a clarification of how the process will flow from one committee to another, i.e., Steering Committee to Citizen Committee, to the Board of County Commissioner, to the Growth Management Steering Committee.
- Kirk described the process and mentioned that city mayors will have some involvement in selecting membership of the Citizens Committee and in shaping the project's recommendations.
- The Citizens Committee will consist of approximately 9-15 members.
- Gary Tollefson asked for clarification on what the Steering Committee will be doing at the May meeting. Would there be an opportunity in this process to amend the scenarios or are we looking at them as very distinctly different?
- Kirk responded that the intent of the initial four scenarios is to draw distinct differences. The Citizen Committee will work to develop a preferred vision and future that draws on all of the scenarios and includes new ideas as well.

- Keith Folkerts from Kitsap County, which has done alternative futures analysis before, spoke about the distinctions between development and ecological scenarios as bookends for comparison purposes.
- Shirley Solomon asked how the Steering Committees time will be allocated in relation to the Citizens Committee. She wondered if the Steering Committee stays in place as the Citizens group ramps up their work.
- Kirk said there would likely be a continuing role for the Steering Committee such as helping with Citizen Committee orientation or public engagement. Perhaps not all Steering Committee members will become involved depending on their interest(s).
- Shirley said floodplain and wetland restoration should be more fully addressed in the ecosystem scenario as described in the Skagit Chinook Recovery Plan. She also said the ecosystem scenario should remove people and development from the floodplain.
- Jan Ellingson talked about the challenges of moving people out of floodplain and other areas identified for restoration and finding comparable locations for them to live.
- John Bolte said the model will clearly include restoration activities when it is more fully developed.
- Kirk gave an overview of the supplemental grant proposal. Shirley Solomon, Margaret Studer and Jan Ellingson noted that they were interested in the public process.
- Jan Ellingson made a recommendation regarding the name of the "unplanned growth" future. She would like to keep the title as Development Future until we think of something better.
- Kirk spoke about changing the Alternative Futures name, possibly something more compelling.
- Next Steering Committee meeting is scheduled for Wednesday, May 5th at the usual location at Skagit Valley College. Possibly it will be a five hour meeting.

The meeting adjourned at 11:50 a.m.
