**ADDITIONS TO
SKAGIT COUNTY PUBLIC HEALTH DEPARTMENT
SCHEDULE OF CHARGES**

WHEREAS RCW 70.05.060(7), relating to the powers and duties of boards of health provides that such boards shall "establish fee schedules for issuing or renewing licenses or permits, or for such services as are authorized by law and the rules and regulations of the State Board of Health; provided, that such fees for service shall not exceed the actual cost of providing any such service"; and

WHEREAS the implementation of proposed Chapter 20 in Title 12, Secure Medicine Return, will incur costs to Public Health; and

WHEREAS the cost is to be borne by the pharmaceutical producers or group of producers participating in a stewardship plan; and

WHEREAS a Notice of Public Hearing was published in the Skagit Valley Herald February 1, 8 and 15, 2018 and the proposed changes were published on the Skagit County Public Health Department website beginning January 29, 2018; and

WHEREAS a Public Hearing to discuss the proposed fee revisions was held February 21, 2018, at 9:30 am.

NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED that the additions to the Skagit County Public Health Schedule of Charges as presented in Attachment A be adopted, effective March 1, 2018.

Initial Plan Review (first 50 hours)	\$4750
Annual Operating Fee (first 120 hours)	\$11400
Revision of Approved Plan (first 3 hours)	\$285
Review of Petition for Alternative Disposal (first 3 hours)	\$285
Civil Penalty – Violation of SCC 12.20 – first offense (may be assessed daily)	\$1000
Civil Penalty – Violation of SCC 12.20 – subsequent offense in twelve months (may be assessed daily)	\$2000
Hourly rate (if additional hours required)	\$95
