## I. Welcome – Lisa Tremblay, Chair

## III. Review and approval of February 10, 2016 minutes

## IV. Jail Update – Marc Estvold

The outside walls of the jail are going up within the week. The plan is to tip the walls up, put the roof on, and start doing the work inside the building in that order. The building should be up by Spring 2017. The County is now starting to look at the inside design and furniture for the interior.

The funding from DOE has slowed down some but the County is hoping that DOE will come through with what they originally agreed to fund.

The building is on schedule and on budget.

Mr. Estvold gives a monthly presentation to the Commissioners on the progress of the new jail the first Tuesday of every month at 2:00 p.m. Cathy Sisk will get the link and send it to members.

County Administrator Tim Holloran advised that the ground soil is still not clean and they will continue to work on de-contamination.

Chief Wend explained how they have to strategize around the dewatering/rain as they work to place the last of the underground lines. This work will be scheduled for late summer/fall in order for the water table to drop.

## V. Presentation – Population Health Trust Community Health Assessment by David Jefferson, Health Analyst

David Jefferson presented on the findings of two community health assessments that were completed in 2015 and shared with the community. One involved a review of 78 health indicators that were then prioritized to 12 and the Quality of Life survey that was completed by Skagit County residents. The purpose of the survey was to seek out the areas of greatest concern facing Skagit County families and the underlying causes for the challenges faced. More than 1,500 Skagit County adults participated in the survey, which was implemented in June-July 2015.

The health indicators and survey was divided into 4 distinct areas that matched the Robert Wood Johnson County Health Ranking model with sub-categories as follows:

- Social & Economic Environment
  - Income and Poverty
  - Safety
  - Nutrition and Weight Status
  - Housing
  - Economics and Employment
  - Emergency Preparedness
  
- Physical Environment
  - Natural Environment
  - Living environment
  - Access to Physical Activity Opportunities
  - Access to Health Foods
  - Safety
  - Housing
  - Weight Status
  - Transportation

- Health Care Access and Quality
  - Health Insurance Coverage
  - Medical Care
  - Dental Care
  - Immunization and Screening
  - Pregnancy and Birth
  - Chronic and Non-communicable Disease and Health Care Visits

- Health Behaviors
  - Teen Safety
  - Substance Use
  - Mental Health
  - Nutrition
  - Weight Status and Physical Activity

The findings from the two assessments were presented at five community health forums around the County seeking public input. The next phase is for the Trust members to review all the health assessment information and select a few priorities with confidence they can influence and change for the better. Once the priorities are identified another round of community conversation will take place.
