Previous Meeting Minutes:

There was a motion and second by the Council that the February 13th, 2013 meeting minutes be approved. The motion passed.

PROGRAM: Bill Henkle with Community Action and Melissa Self, Housing Project Manager detailed the Coordinated Homeless Project for Skagit County which began in February. Their top priority is getting homeless housed and back to stability in the community. They accomplish this by capturing resources that were previously untapped and coordinating scattered resources. Right now there are 2 full time housing specialists on staff working with homeless who have been referred to them.

JAIL FACILITY TASK FORCE: Marc Estvold, Project Manager

To recap: 3 sites are still being considered for a proposed new 300-400 bed jail. Members and the public are agreed on the need for a new, larger jail. The remaining issue to resolve is funding. The Commissioners will have their funding plan ready to present at the next meeting of the Jail Coordinating Council on Friday, March 22, 2013. The goal is to have the new jail as a ballot item in August, 2013.

Tim Holloran and **Will Reichardt** both mentioned that a Citizen's Group to support this ballot item will need to be organized. The Group would be organized outside the County structure to handle: Publicity, such as a letter to the editor campaign; Advertising, such as yard signs; and Community support, such as a speakers group to ensure the new jail building will be on the ballot in the Fall, 2013. ORGANIZATION ANNOUNCEMENTS:

Chief Bonnie Bowers urged support of HB1911 which relates to health care services for inmates in city, county, and regional jails

Tim Holloran thanked **Chief Bowers** and **Sheriff Reichardt** and all law enforcement and agencies who participated in support of the Special Olympics Polar Plunge, which raised \$9000 for their worthy cause.
