### **FOLLOW UP ISSUES:**

**Jail Video: Charlie Wend** is working with the video producers to add footage from the patrol perspective and to put further emphasis on the safety factor on the jail overcrowding. The Jail Task Force will activate once the jail video is ready to use in presentations.

**Lisa Rumsey** was introduced in her new position as Juvenile Court Director. The Juvenile Court will now come under the supervision of the Superior Court Judges. Applications will be posted for Juvenile Detention Manager.

**DOC Update: Gregg Freeman** related that the new Tolling Legislation has recently passed and will become effective 7/1/11. This change will shorten the amount of DOC supervision as the clock will no longer stop for any jail time violations during the supervision period.

**Mental Health Update: Chuck Benjamin** brought a recent study that stated 50% of the U.S. Cigarette market is made up of people with serious mental health illness. Perhaps smoking cessation classes would be given a higher priority in the future.
