1. <u>Call to order & introductions</u>:

Chair Oscar Lagerlund called the meeting to order at 6.00pm. He welcomed members and guest Mike Shelby (Western Washington Ag Association) to the meeting.

2. <u>Minutes:</u>

Chair Oscar Lagerlund called for review and correction of the January minutes. Hearing no corrections, the minutes were accepted as submitted.

3. <u>Appointments and Elections:</u>

Chair Oscar Lagerlund requested consideration of the candidate for the seat which will be made vacant by his resignation. Lyle Wesen moved, and Annie Lohman seconded, appointment of Nels Lagerlund as a member of the Agricultural Advisory Board. Motion carried, with Oscar Lagerlund abstaining. The appointment recommendation will be forwarded to the County Commissioners for final approval via resolution.

Chair Oscar Lagerlund opened the floor to nominations for the Agricultural Advisory Board Chair position. Mike Hulbert moved, and Annie Lohman seconded, the nomination of Kim Mower for Chair. Lyle Wesen moved, and Mike Hulbert seconded, to close the nominations. Nominations closed by voice vote. Lyle Wesen called the question on the nomination of Kim Mower as Chair. Kim Mower approved by unanimous voice vote as Chair of the AAB. Oscar Lagerlund passed the gavel to Kim Mower.

Chair Kim Mower opened the floor to nominations for the Agricultural Advisory Board Vice Chair position. Lyle Wesen moved, and Randy Good seconded, the nomination of Mike Hulbert for Vice Chair. After further discussion, Randy Good moved, and Annie Lohman seconded, to close the nominations. Nominations closed by voice vote. Randy Good called the question on the nomination of Mike Hulbert as Vice Chair. Mike Hulbert approved by unanimous voice vote as Vice Chair of the AAB.

4. <u>Legislative Update – Mike Shelby</u>

Mike Shelby, Executive Director of the Western Washington Agricultural Association, gave an update on bills being considered in the Legislature this year. Of particular interest to agriculture are bills related to the Ag-CAO and the proposed Office of

Farmland Preservation. A handout was provided on a variety of bills; the AAB has indicated positions on the following:
