#### **Guest Speaker**

Toby Rogers spoke on soil scientists who can refer to themselves as soil scientists versus wetland scientists. A bill is working through Olympia to distinguish the two categories. Problems have occurred with septic systems with poor judgments being made. There are about 60 soil scientists in Washington State and 200 to 300 wetland scientists.
