- Nels asked Hal Hart, Planning & Development Services Director if he has any info on this with the County, Hal said he would check on it and report back if there is anything to report.
- Michael Hughes & Nels Lagerlund assured Mr. Macku that when something moves forward regarding his
  concerns that they will have a Public Comment Period and that is when they can submit their
  comments.

- All Tasting Rooms are violating trying to get out of paying taxes and nothing is happening
