Notice is hereby given that the Skagit County Hearing Examiner will hold a public hearing on **Wednesday, November 18, 2020 at 9:00 a.m.** or soon thereafter, for the purpose of determining the following:

- a. **Critical Areas Variance PL20-0181.** Shell Puget Sound Refinery requests to reduce the buffer on a Category IV wetland to expand an existing impounding basin to provide additional capacity for stormwater runoff. The existing basin measures approximately 280 feet long by 65 feet wide and the expansion would increase capacity to 46,500 cubic feet. A wetland is adjacent to the existing basin and the expansion would reduce the buffer from 50 feet to 15 feet for approximately 150 feet. The area available for the basin expansion is limited due to roads, LNG pipelines, and a railroad that surround the project site. The proposed project is located within a portion of the property described as parcel number P33502. The site is located at 8505 South Texas Road within a portion of the SW ¼ of Section 33, Township 35 N, Range 2 E, W.M. Staff Contact: Leah Forbes, Senior Planner
