• Steering Report

Bill gave an update on the most recent Steering Report on July 9th. Highlights were:

- \checkmark Identifying the piece of the SCOG housing report has traction and a role for PHT
- ✓ Educating the PHT on the Housing Report and enabling an easy way to advocate for it in regards to health in our community
- ✓ InsightVision

• Update

Liz Lovelett gave a report back on the Association of WA Cities conference last month, in which Housing was the hot topic. She shared on the program adopted by King County-LEAD-Law Enforcement Assisted Diversion. This is Law Enforcement Assisted Diversion (LEAD) is a new innovative pilot program that was developed with the community to address low-level drug and prostitution crimes in King County. LEAD will divert low-level drug and prostitution offenders into community-based treatment and support services – including housing, healthcare, job training, treatment and mental health support -- instead of processing them through traditional criminal justice system avenues. A unique coalition of law enforcement agencies, public officials, and community groups collaborated to create this pilot program. These groups make up LEAD's Policy Coordinating Group, which governs the program. <u>http://leadkingcounty.org/about/</u>

Liz also shared Walla Walla has adopted regulation to allow Community Supported Shelters which houses Conestoga tents for the homeless community. This is a safe sleep space, facilitates single occupancy at a 10 month duration cap, located in a gated area, and is individually secured. Through collaborative efforts by the Walla Walla community, offered is Porta potties, Sharps containers, running faucet. The Community is Substance use-free, About \$1000 per unit which makes it inexpensive to build and is also durable and long-lasting. <u>http://communitysupportedshelters.org/</u>

Housing White Paper review

David shared a draft of the white paper with the membership earlier in the week, and shared some feedback given thus far and asked for additional input from the group.

Questions/Comments

- Mary shared a suggestion for a title of "the connection between health and housing" due to the nature of the white paper and reason it pertains to PHT
- John suggested to make it more explicit, not only why PHT cares about housing, but the fact that housing is imperative to enable change. Such as "Health starts with Housing"
- Bill shared "What is this for?" to bring attention to the SCOG report but education to the public of the need in our community and advocacy for change
- John suggested to make sure market rate and availability isn't comparable it will skew the affordability of housing
- Kevin shared the importance of finding the balance of including piece of information without duplicating the SCOG report, enough but not too much
- Mary suggests to add a 7th point from Education
- JSW suggests the economic health impacts of low availability in our county for employers and businesses
- > Liz suggested the costs of inaction be included-hospital, law enforcement, etc.
- Mary suggests including a purpose statement and caveat paragraph that this is just a snapshot of housing and health
- Liz suggested to include the PHT Members list

Through robust discussion, the group agrees to include those suggestions and bring a draft for approval from the PHT, as well as the draft Resolution that accompanies it at the September 6 membership meeting
