• Data Dashboard Preview-Dr. Patrick Jones

Dr. Jones shared a preview of our Data Dashboard "Skagit County Trends." Dr. Jones went through each icon, touching on various data points and providing user sneak peeks to show the ease and resource tools the website offers. Though not complete, Eastern Washington has made available a test site for a small window of time.

David shared that, as the PHT, we have strength in most of these areas with deficiency in "Pooled, Nimble Resources." Establishing a plan to build up this area will make us ready for upcoming grant opportunities. The upcoming Fiscal Workgroup will begin deliberating on this issue and report back to the PHT.

• Opioid Workgroup Leadership Team Update-Chris Johnston

Chris updated the membership on the progress of the OWLT group, touching on the assessment of programs available, gaps in the system, and the list of priorities the group decided on. The OWLT groups will be making a presentation at the next PHT Membership meeting on November 3rd.

Steering Committee Meeting-Liz McNett Crowl

Liz shared the progress of the Steering Committee, specifically the RWJ model and how indicators fit within it, how the drivers are valid, and the overlap of the action areas.

Drivers-How could we accelerate & promote change?

David shared data from the OWLT group and charged the group with using the data to piece together the drivers, in order to look at ways we can promote change within this indicator. The group shared ideas on how to address these issues in the community and with providers, including alternative pain management, diminishing stigma, education, increasing our civil engagement and the ripple effects of change.

Position Papers-

David shared that the PHT has been approached by 2 organizations for Letters of Support.

First, Skagit PICKS is a program through a collaboration of Skagit Pediatrics, Skagit Valley Farmers market Coalition, and WSU Extension to enable Medicaid patients to increase healthy food access via Well Child checks.

The group made a motion to provide a letter of support, seconded the motion, and voted to approve.

Second, the Swinomish Indian Tribe asked for a Letter of Support for the local tribal/non-tribal Health Clinic that is in the process of licensure and building. This was announced at the last PHT Meeting on September 1. The group made motion to provide a letter of support, seconded the motion, and voted to approve.
