Welcome & approved previous meeting minutes

• Retreat Review

The group was asked for feedback from the PHT Retreat on May 4, 2017, the following was shared:

- The keynote speaker was the best part of the day-hearing the details about a huge undertaking such as this initiative. It was valuable to bring community and government together and to listen and explore how they feel about the current Skagit County climate

The group agreed to start a conversation at our June PHT Membership meeting regarding an initiative like Best Starts For Kids in Skagit County and include additional information such as next steps and the PHT's role.

Opioid Update

Kristen shared an update on the OWLT work, which includes:

- ✓ Kristen and Linda Crothers from North Sound Behavioral Health Organization (NSBHO) are in the process of co-chairing the ACH workgroup.
- ✓ NSBHO has created a regional work plan which includes their priorities and will be considered at the ACH workgroup. Skagit County is the only county out of our region that has done an Opioid plan, which could give our action items priority consideration in the regional plan. Skagit County priorities are being merged into the ACH plan.
- ✓ Kristen shared we have been working with the GIS department to develop a Narcan distribution map so Phoenix Recovery Services can highlight the gaps in Narcan coverage in Skagit County.

- ✓ There has been a meeting scheduled with Skagit Emergency Medical Service (EMS), Phoenix Recovery Services and Kristen to re-establish the previous collaboration relationship and to develop an ongoing work plan.
- ✓ A group (Will Reichardt, Randy Elde, Britt Pfaff-Dunton, Julie de Losada, Charlie Wend, Kristen Ekstran, Carol Hawk, Stephanie Morgareidge, Hayley Thompson, Alicia Hughes & Christine Valdez) met last week for a drug take-back meeting and are discussing a possible ordinance in lieu of the state's inaction.
- ✓ The next OWLT meeting is scheduled for Thursday May, 11, 2017.

- ✓ The ACH has hired an Epidemiologist (Nicole Willis) formerly from Whatcom county, and are in the process of hiring for a couple other positions.
- ✓ The Pathways model has been chosen as a 3rd established Action Item (in conjunction with Opioids and Bi-directional Integration).
