- Housing Report & Intersection with the Trust

Kevin shared a draft of the Housing Action Plan with the group, and highlighted some information, such as:

- Some community meeting participants have used the event to share frustration with city entities for not making larger efforts to change the housing crisis.
- Skagit County and the municipalities have limited resources to expand the housing infrastructure.
- ➤ The Action Plan is a five-seven year roadmap for addressing the low-and moderate-income housing needs. It is a broad set of strategies and associated actions that will be taken on by community partners.
- ➤ Mount Vernon is researching zoning changes and options for smaller multi-family ownership units.
- The main concern for elected officials regarding a levy is burdening the tax base.
- Capacity remains the central barrier to progress.
- There is a significant gap in builder costs/wages in this county.
- ➤ The base income of Skagit residents is low enough that many builders don't foresee a sufficient profit motive to build houses of a certain size.

What would the Trust like to hear about from this plan? The group suggested:

- ✓ A description of how the community would change if the plan were fully executed
- ✓ Details about the levy proposal
- ✓ Who might have what role in the plan
- ✓ What the Trust's role might be
