## DETERMINATION OF NONSIGNIFICANCE/NOTICE OF AVAILABILITY AND PUBLIC HEARING SKAGIT COUNTY PLANNING COMMISSION

REGARDING PROPOSED AMENDMENTS TO SKAGIT COUNTY CODE UNIFIED DEVELOPMENT CODE, TITLE 14, SECTIONS 14.04 DEFINITIONS, 14.06 PERMIT PROCEDURES, 14.08 LEGISLATIVE ACTIONS, 14.16 ZONING, 14.18 LAND DIVISIONS, 14.20 MASTER PLANNED RESORTS, 14.24 CRITICAL AREAS ORDINANCE, AND 14.42 ACCEPTING GRANTS OF REAL PROPERTY.

**Description of Proposal:** A non-project legislative action to amend the Skagit County Unified Development Code correcting typographical errors, adding clarity, rectifying inconsistencies, including needed provisions, and general refinement of the existing regulations. Several new provisions are also proposed.

Notice of Public Hearing: A public hearing on the proposal will be held on Tuesday, April 5, 2011, in the Skagit Room of the Skagit County Commissioners' Administrative Building located at 1800 Continental Place, Mount Vernon, Washington, beginning at 6:00 p.m. or as soon thereafter as possible, and continuing until 9:00 p.m. or no further comment is forthcoming. Deliberations on the matter may begin on April 5, 2011, or continued until a later meeting in April or May 2011.

Public Comment: Your views for or against the proposed modifications are invited by attendance, representation, or letter. Maps must be in black and white and also reduced to 8 ½" x 11" size for reproduction purposes. Submittals not meeting these requirements will, unfortunately, not be considered. Please specifically reference the proposed ordinance or issue that the comments relate to.

**SEPA Threshold Determination:** Skagit County has determined that this proposal does not have a probable significant adverse impact on the environment. An environmental impact statement is not required under the State Environmental Policy Act (SEPA) RCW 43.21C.030(2)(C). This determination was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public upon request.

This determination is issued pursuant to WAC 197-11-340(2) and WAC 197-11-630. Skagit County will not act on this proposal for fifteen calendar days from the date of issuance. Comments regarding this Determination of Non-significance must be submitted by Monday, March 21, 2011, and in the same manner as outlined above for public comments.

Pursuant to SCC 14.12.210, no administrative appeal process is available for this legislative action.
