### Proposal Description

Planning and Development Services (PDS) proposes to include an additional map amendment (item C-19) for the Board of County Commissioner's considerations for inclusion on the 2018 Docket. The land use and zoning designation of 37 privately-owned parcels totaling approximately 2759 acres in the public Open Space of Regional / Statewide Importance (OSRSI), within the boundaries of the Mount Baker-Snoqualmie National Forest, would be modified to the Industrial Forest – Natural Resource Lands (IF-NRL) or Natural Resource Industrial (NRI) zoning designation. This map amendment would be accompanied by the Mineral Resource Overlay (MRO) over the subject parcels where appropriate based on the MRO designation criteria.

The Department has received four citizen-initiated amendments and proposes eighteen County-initiated text amendments (one in the Comprehensive Plan and seventeen in Skagit County Code Title 14) for inclusion in this year's docket. One County-initiated map amendment (P-12: South Fidalgo Island Rezone) was deferred from the 2017 Docket for further analysis. The Board of County Commissioners will make a decision on which petitions to move forward (docket) for full review and potential adoption after considering public comment. The Department has analyzed the petitions pursuant to the adopted Countywide Planning Policies, the Skagit County Comprehensive Plan, and Skagit County Code (SCC) 14.08 and issued a memo with recommendations. The materials from the November 21 public hearing, the December 19 deliberations, and the staff report in advance of the second public hearing on January 16 in order to consider the OSRSI map amendment are available to view at [www.skagitcounty.net/2018CPA](http://www.skagitcounty.net/2018CPA). Detailed descriptions of each proposal, Department analyses, maps showing the proposed land use map changes, and the public noticing documents are all available to view at the above-listed website.

## **Environmental Review (SEPA)**

Pursuant to SCC 14.08.050, after the Board of County Commissioners establishes the year's docket of amendments, the County must complete environmental review of all of the proposed amendments. For a site-specific Comprehensive Plan amendment, the applicant must submit a complete environmental checklist to the County and required fees.
