Summary

This proposal updates the Capital Facilities Plan (CFP) and related documents, which the County typically updates every year. Older versions of the plan are available on the proposal website at www.skagitcounty.net/cfp. The proposal incorporates by reference the County's updated Transportation Improvement Program (TIP), which is being proposed in concurrence with updates to the CFP. The TIP helps fulfill the County's GMA requirement for transportation planning. The most recent redlines to the TIP are available at the following website: https://www.skagitcounty.net/Departments/PublicWorksEngineering/programsmain.htm.

PDS issued a staff report and proposed updates to the CFP and the TIP on August 31, 2017, in advance of the Planning Commission Public Hearing held on September 19, 2017. The report and redlined CFP and TIP are available on the proposal website at www.skagitcounty.net/cfp. This supplemental staff report is being issued in advance of the deliberations scheduled for October 3, 2017 to address public and agency comments concerning the proposed updates. The public comment period ended on September 21, 2017.

Public Comments

No SEPA agency comments or Department of Commerce comments were received during the comment period. Written comments were submitted to the Public Works Department regarding the proposed updates to the TIP pursuant to an open house community meeting held on September 14, 2017 (Attachment 1). No written comments were submitted to the Planning Department regarding the proposed updates to the CFP. The following oral testimony was submitted during the public hearing for the CFP and TIP on September 19, 2017:

- Ms. Carol Ehlers stated that the Capital Facilities Plan was part of Natural Hazard Mitigation planning, and directed the Planning Commissioners to consider the proposed Fire District improvements and the Stormwater Management Plan for Fidalgo Island. Ms. Ehlers requested that the Transportation Improvement Program include plans for more pullouts adjacent to roads on Fidalgo Island. PDS staff has notified the Public Works team of this request.
- School Superintendent Dr. Carl Bruner of the Mount Vernon School District No. 320 stated that
 the District's own Capital Facilities Plan was being updated, and should be adopted by the Board
 of Directors next month. The District will provide the County with a copy of the updated District
 CFP prior to adoption of the County's 2018 and 2023 CFP. The County will include the District's
 updated Capital Facilities Plan into the Non-County Capital Facilities School District chapter of
 the CFP.

Recommendation

Skagit County PDS recommends that the Planning Commission forward a recommendation to the Board of County Commissioners to adopt the proposed updates to the 2018-2023 Capital Facilities Plan and the Transportation Improvement Program
