The 2012 Comprehensive Plan Amendment Docket will be sent to the Department of Commerce 60-day review pursuant to RCW 36.70A.106. There will be a public comment period and public hearing before the Skagit County Planning Commission on November 5, 2013. Skagit County Planning and Development Services (the Department) intends to bring the proposal forward to the Board of County Commissioners in time for final action before the end of 2013.

The language of the 2012 Skagit County Parks and Recreation Comprehensive Plan may be revised during the public review and comment process.

A public hearing before the Skagit County Planning Commission will be held and a recommendation from the Planning Commission will be forwarded to the Board of County Commissioners. Board of County Commissioner approval is required before any change to the Comprehensive Plan. The Board of County Commissioners' action, if appealed, is subject to review by the Growth Management Hearings Board.

Three (3) County initiated proposals are being considered, two (2) of which include amendments to the Skagit County Comprehensive Plan Land Use and Zoning maps; and, one (1) amendment to incorporate by reference the 2012 Skagit County Parks and Recreation Comprehensive Plan.

C-1. Proposal to amend Skagit County Comprehensive Plan to incorporate by reference the 2012 Skagit County Parks and Recreation Comprehensive Plan.

C-2. Proposal to re-designate and rezone P118792, an approximately .3 acre parcel owned by Del Mar Community Service on which are located two water tanks, from Rural Resource-NRL (RRc-NRL) to Rural Reserve (RRv). The subject parcel is generally described as located on Fidalgo Island, south of Marine Drive, east of Rosario Road, and north and west of Sharpe Lane/Sharpe Road. The parcel immediately to the northwest, P19168, was redesignated from Rural Resource-NRL to Rural Reserve in the 2011 Comprehensive Plan Amendment Docket, leaving P118792 as an isolated island or spot zone of Rural Resource-NRL. This proposal would remedy that situation by re-designating P118792 to Rural Reserve, consistent with the properties surrounding it on all sides.

C-3. Proposal to re-designate and rezone 4 parcels (P74450, P103560, P103559, P74451), 1.5 acres in size, to Rural Business (RB). The subject parcels are generally described as located along the east side of the Swinomish Channel, and north and west of the Town of LaConner and the Port of Skagit County. The subject properties were designated and zoned Commercial in 1992. Subsequent comprehensive plan updates indicated, in error, that the property was located within the corporate limits of the Town of LaConner. The proposal rectifies the inadvertent mapping error.



D. SUPPLEMENT SHEET FOR NON-PROJECT ACTIONS

The two (2) proposed map amendments (C-2 & C-3) are site specific. Any future development resulting from the proposed map amendments is not likely to result in any significant increase in discharges, emissions, production or release of any of the above, beyond what is already occurring or permitted. Any specific development resulting from these amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions.

In general the development of parks and recreation facilities (C-1) are consistent with the development of other non-industrial or non-heavy commercial areas. There is typically some impact during construction that is managed and/or mitigated. Any specific development resulting from these amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The two (2) proposed map amendments (C-2 & C-3) are site specific. Any future development resulting from the proposed map amendments is not likely to result in any significant affects to plants, animals, fish, or marine life, beyond what is already occurring or permitted. Any specific development resulting from these amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions.

The Skagit County Parks and Recreation Comprehensive Plan (C-1) prescribes that current and anticipated future projects will protect plants, animals, fish and marine life and includes removal of invasive weed populations, planting and enhancing buffers on streams and shorelines, and moving to an organic maintenance program that does not use herbicides and pesticides and relies solely on organic fertilizers and organic pest control. Since the last Skagit County Parks and Recreation Comprehensive Plan the parks department has acquired approximately 90 acres of additional open space and a

marine shoreline for low impact recreation use (trails) as well as protection of existing habitat and wildlife corridors.

3. How would the proposal be likely to deplete energy or natural resources?

The two (2) proposed map amendments (C-2 & C-3) are site specific. The proposed amendments will not result in any significant depletion of energy or natural resources beyond what is already occurring or permitted. Any specific development resulting from these amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions.

There are no elements of Skagit County Parks and Recreation Comprehensive Plan (C-1) that are likely to deplete energy beyond the energy required to support the maintenance and operation of park facilities.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection; such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The two (2) proposed map amendments (C-2 & C-3) are site specific. The proposed amendments would not adversely affect environmentally sensitive areas, etc. Any specific development resulting from these amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions.

Skagit County Parks and Recreation Comprehensive Plan (C-1) projects are unique forms of development that often highlight and integrate environmentally sensitive areas for education and appropriate recreational uses such as wildlife viewing and photography.

Proposed measures to protect such resources or to avoid or reduce impacts are:

Any development resulting from the proposed amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal statutes.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The two (2) proposed map amendments (C-2 & C-3) are site specific. Proposal C-3 is located adjacent to the Swinomish Channel. Any specific development resulting from the amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal statutes including the Shoreline Management Master Program.

The Skagit County Parks and Recreation Comprehensive Plan (C-1) encourages the sustainable use of shorelines for passive and active recreations, including but not limited to fishing, boating access, wildlife viewing and scenic enjoyments.

Proposed measures to avoid or reduce shoreline and land use impacts are:

Any possible use or effect from any specific development resulting from the amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal jurisdictions including the Shoreline Management Master Program.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The two (2) proposed map amendments (C-2 & C-3) are site specific. As such, any future specific development proposals would not likely increase demands for transportation or public services and utilities beyond levels already anticipated and planned for in the Comprehensive Plan and related implementation measures. Furthermore, any specific development resulting from the amendments shall be subject to all applicable codes, regulations and statutes from the local, state and federal statutes.

Skagit County Parks and Recreation Comprehensive Plan (C-1) projects resulting from the plan will be subject to all applicable codes, regulations and statutes from the local, state and federal statutes.

Proposed measures to reduce or respond to such demand(s) are:


