What is the 2016 Comprehensive Plan Update?

- Periodic update required by state law
- To consider new laws, population & employment growth, & local conditions

What is under review?

- Countywide Planning Policy 1.1 (population and employment projections)
- Skagit County Comprehensive Plan
- Development regulations (SCC Title 14)
- Land Use & Zoning Map

What is the focus of the update?

- The Board of County Commissioners has already established a scope of work:
 - Focus primarily on what's required
 - Complete the update on time
- What are some of the key issues?

Population and employment growth

- Forecast to 2036
- Allocations among jurisdictions
- Developed among the County, Cities and Towns (GMA Steering Committee)
- Requires formal consideration and approval by each jurisdiction

Urban growth area ("UGA") sizing

• Possible UGA expansions:

- o Sedro-Woolley
- Burlington (limited, for farmworker housing)
- Mount Vernon and other cities and towns maintaining current UGA boundaries

Transportation Element

- Impacts of growth on traffic & transportation
- Needed expansions & how to pay for them
- Bicycle & pedestrian component required
- Focus of March 2015 workshop with Planning Commission

Housing Element

- Is there adequate housing to meet current needs and projected growth?
- How can the County, cities and towns work together to help provide adequate affordable housing?
 Approx. 40% of Skagit County residents are "cost burdened"
- Focus of February 2015 workshop with Planning Commission

Rural Element

- Are permitted uses in Rural zones appropriate to maintain rural character, while providing adequate housing and economic opportunities?
- Particular focus on Rural Intermediate, Rural Reserve, and Rural Village Residential
- Focus of May 2015 workshop with Planning Commission

- October 27: Big Lake Fire Hall
- November 10: Edison Elementary School

Planning Commission hearings and deliberations	April – May 2016
Board considers Planning Commission recommendations, adopts final 2016 Update amendments	June 2016
