Proposed compliance measures in Western Washington Growth Management Hearings Board Order in Case No. 02-2-0012c and establishing the Salmon Heritage Program

Notice is hereby given that the Skagit County Planning Commission and the Board of County Commissioners will hold a joint public hearing on Tuesday, April 24, 2007 at 7 p.m. or as soon thereafter as possible to receive public comment on a proposal to amend Skagit County Code Title 14 and associated Resolutions necessary to achieve compliance with the Western Washington Growth Management Hearings Board Order in Case No. 02-2-0012c and to establish the Salmon Heritage Program. The hearing location is the Skagit County Commissioners Hearing Room, 1800 Continental Place, Mount Vernon, WA. The proposal is intended to better protect salmon habitat and water quality in areas zoned Agriculture-NRL and Rural Resource-NRL in unincorporated areas of Skagit County.

On March 22, 2007 Skagit County will make available the proposed code amendments and related documents on its website at www.skagitcounty.net. The documents to be made available include:

SEPA Documents: The legislative actions contemplated in this proposal have received a Determination of Non-Significance (DNS). These DNS determinations were issued on March 20, 2007 and published on March 22, 2007. The resolution authorizing a tax levy approval to fund the Salmon Heritage Program was determined to be categorically exempt under WAC 197-11-800 (14)(b). SEPA documents can also be viewed on www.skagitcounty.net.

Comments: March 22, 2007 will also mark the beginning of a 60-day public and agency review and comment period. During this period there will be informational open houses and a public hearing before the Planning Commission. The deadline for written comments to the Planning Commission is April 27, 2007. The Planning Commission will then formulate and forward its recommendations on the proposed code amendments to the Board of County Commissioners for final consideration and possible adoption. The Board of County Commissioners will also deliberate and take action on the related resolutions listed above. The current target date for

possible adoption is late May 2007, after completion of the 60-day period for public and agency review specified under GMA.

How to comment: Whether you agree or disagree with the proposal, you are encouraged to comment. Comments may be submitted in writing to Skagit County Planning and Development Services, at 1800 Continental Place, Mount Vernon WA 98273 and must be received by Friday April 27, 2007 at 4:30 p.m to be considered by the Planning Commission as part of its deliberations. Comments may also be made at the public hearing scheduled before the Skagit County Planning Commission and Board of County Commissioners. The 60-day review period required by GMA ends on May 21, 2007.

Written correspondence submittal requirements: Comments on the proposal must be submitted on 8 ½" x 11" paper. Maps must be in black and white and also reduced to 8 ½" x 11" size for reproduction purposes. Submittals not meeting these requirements will, unfortunately, not be considered.
