Good morning Planning Commissioners,

It was brought to my attention that staff recommendation #6 regarding Policy 2G-1.1 within the Land Use element needs some additional work (see policy below). The policy recommendation should include Industrial Forest – Natural Resource Lands to be consistent with SCC 14.18.310(2) and the language should be amended emphasize the long-term protection of forest land in addition to agricultural land. Below is the amended policy recommendation.

Previous Recommendation # 6. Revise 2G-1.1 to include Secondary Forest Natural Resource Lands. Policy 2G-1.1 Allow the separation of an existing house from the larger parcel where it is located on lands designated Agricultural-Natural Resource Land, Secondary Forest – Natural Resource Land, and Rural Resource-Natural Resource Land in order to encourage long-term protection of agricultural land. Establish conservation easement on the separated resource land in perpetuity.

<u>Amended Recommendation #6</u>. Revise 2G-1.1 to include Secondary Forest Natural Resource Lands and Industrial Forest Lands consistent with SCC 14.18.310(2). Policy 2G-1.1 Allow the separation of an existing house from the larger parcel where it is located on lands designated Agricultural-Natural Resource Land, Secondary Forest – Natural Resource Land, Industrial Forest-Natural Resource Land, and Rural Resource-Natural Resource Land in order to encourage long-term protection of agricultural land and forest land. Establish conservation easement on the separated resource land in perpetuity.
