

**-SKAGIT COUNTY PLANNING AND DEVELOPMENT SERVICES NOTICE OF DEVELOPMENT

Notice is hereby given that on July 28, 2016 Richard Simmons filed a Reasonable Use Exception Application to allow residential development on Parcels # P75225, 75240, and 75241 as a single unit of property for development. The subject property is approximately 20,000 sq. ft. in size and is located within the Rural Intermediate (RI) zoning/comprehensive plan designated area as identified within the Skagit County Comprehensive Plan and associated maps as adopted July 24, 2000 and as thereafter amended. The minimum lot size in the Rural Intermediate zoning designation is 2.5 acres. Thus the subject property is considered substandard to the Rural Intermediate designation. Pursuant to Skagit County Code (SCC) 14.16.850(4)(f), a Reasonable Use Exception is required for development on a substandard parcel under certain circumstances.

A letter of completeness was not issued. However, the application was determined complete on September 1, 2016.

The subject property is located on the West side of Wharf Street and adjacent on the north to 4784 Wharf St. (P73245); the property is identified as Parcels P75225, 75240, and 75241 as a single unit of property for development; and is described as a Ptn of Lots 8 & 9, Blk 5, and Lots 1, 2, & 3, Blk 10, Map of the Town of Samish Island, Whatcom County, recorded in Vol.2 of Plats, Page 71, June 18, 1883.

A Reasonable Use Exception Application, Lot Certification determination and other application materials are on file with the Skagit County Planning and Development Services. This information is available to the public upon request.

Other governmental approvals or permits that will be needed for this proposal include:

- All applicable development permits

A decision on the application will be made within 120 days of the date the application was determined to be complete, which was September 1, 2016. A public hearing before the Skagit County Hearing Examiner is not required for this project.

Any person desiring to express his or her views or be notified of the action taken on this application should notify Grace Roeder in writing of his or her interest within fifteen (15) days of the date of publication of this notice.
