Notice is hereby given that on February 21, 2017 Nola Two Feathers on behalf of Stan Fox submitted a Reasonable Use Exception Application to allow residential development on Parcel # P 17995. The subject property is approximately 13,000 sq. ft. in size and is located within the Rural Village Residential (RVR) zoning/comprehensive Plan designated area as identified within the Skagit County Comprehensive Plan and associated maps as adopted July 24, 2000 and as thereafter amended. The minimum lot size in the Rural Village Residential zoning designation is either one (1) acre with public water and public sewer or 2.5 acres with on-site water (well) and on-site sewage disposal. Thus the subject property is considered substandard to the Rural Village Residential designation. Pursuant to Skagit County Code (SCC) 14.16.850(4)(f), a Reasonable Use Exception is required for development on a substandard parcel under certain circumstances.

A letter of completeness was issued and the application was determined complete on February 28, 2017.

The subject property is described as "Parcel A" of Record of Survey AF 200503180158, as interpreted from Treasurer's Conveyance, AF 894969; within a Ptn of the Northeast ¼ of the Northeast ¼ of Section 7, Township 33 North, Range 5 East, W.M, Skagit County, Washington. The subject property is located on the West side of State Route 9, somewhat across from 19255 State Route 9, Mount Vernon, WA.

A Reasonable Use Exception Application, Lot Certification determination and other application materials are on file with the Skagit County Planning and Development Services. This information is available to the public upon request.
