NOTICE OF DEVELOPMENT APPLICATION AND SEPA COMMENT PERIOD**

Notice is hereby given that on May 4, 2017, G & D Wallace Inc. filed an independent State Environmental Policy Act (SEPA) checklist #PL17-0234 for the construction of an 11,392 square foot (89' x 128') potato storage building with a 50' x 89' concrete pad for loading and unloading. The proposed project is located within the Agricultural – Natural Resource Lands (Ag-NRL) zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016 and as thereafter amended. A letter of completeness was not issued and the application was determined to be complete for review purposes on May 8, 2017.

The project is located along the east side of Pulver Road at 10517 Pulver Road, immediately south of the intersection of Pulver and Maiben Road, Burlington, within a portion of Section 30, Township 35N, Range 4E W.M., situated within Skagit County, Washington. (P38089)

A completed Environmental Checklist, site plan, and other application materials are on file with Skagit County Planning and Development Services. This information is available to the public on request. Other governmental approvals or permits that will be required for this proposal from Skagit County Planning and Development Services include: Approved building and floodplain permits.

A decision on the application will be made within 120 days of the date the application was determined complete, which was 5-8-17. A public hearing before the Skagit County Hearing Examiner is not required for this project. Any person desiring to express his or her views or to be notified of the action taken on this application should notify Brandon Black in writing of his or her interest within Fifteen (15) days of the date of publication of this notice which is 5-11-17. Failure to respond within the comment period could result in loss of the right to appeal. The file can be viewed at Planning and Development Services which is located at the Continental Place address listed below.

Written comments must be received no later than 4:30 pm on: **May 26, 2017**
Email correspondence **will not be accepted**, however, comments may be submitted via the PDS website under the “current legal notices” tab. (www.skagitcounty.net/pdscomments)

The Lead Agency expects to issue a DNS for this proposal and the Optional DNS process is being used (WAC 197-11-355). **This may be the only opportunity to comment on the environmental impacts of the proposal.**
