Notice is hereby given that on September 14, 2017, Tony Wisdom, on behalf of Skagit Farmland LLC, filed an independent State Environmental Policy Act (SEPA) checklist #PL17-0505 for the construction of a new stand-alone product operations (cooling/handling/shipping) facility with a footprint of approximately 98,000 square feet, and a 30,000 square foot product storage addition to an existing 28,000 square foot agricultural product storage building. The proposed project will include the excavation of approximately 19,236 cubic yards of material and the placement of approximately 57,756 cubic yards of material. Several existing structures will be removed and/or relocated off site to accommodate the product operations facility. The proposed project is located within the Agricultural – Natural Resource Lands (Ag-NRL) zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016 and as thereafter amended. A letter of completeness was not issued and the application was determined to be complete for review purposes on September 25, 2017.

The project is located at 11261 and 11263 Pulver Road, Burlington, within a portion of Section 31, Township 35N, Range 4E W.M., situated within Skagit County, Washington. (P38129)

A completed Environmental Checklist, site plan, and other application materials are on file with Skagit County Planning and Development Services. This information is available to the public on request. Other governmental approvals or permits that will be required for this proposal from Skagit County Planning and Development Services include: Approved building and floodplain permits.

A decision on the application will be made within 120 days of the date the application was determined compete, which was 9-25-17. A public hearing before the Skagit County Hearing Examiner is not required for this project. Any person desiring to express his or her views or to be notified of the action taken on this application should notify Brandon Black in writing of his or her interest within Fifteen (15) days of the date of publication of this notice which is 9-28-17. Failure to respond within the comment period could result in loss of the right to appeal.
