PROJECT DESCRIPTION: Notice is hereby given that on February 24, 2020, Skagit County Planning and Development Services approved the State Environmental Policy Act (SEPA) checklist review completed in conjunction with Grading permit application #BP19-1010 for the construction of two (2) airplane hangar structures of approximately 12,064 square feet each (24,128 square feet total combined). The project includes the excavation of approximately 2,000 cubic yards of material and the placement of approximately 7,000 cubic yards of structural fill and surfacing material. The proposed project is located within the Aviation Related (AVR) zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016 and as thereafter amended.
