- a. Mining Special Use Permit application #PL16-0556 requests the expansion of an existing mining operation from 17.78 acres to approximately 53.5 acres. - b. **Special Use Permit application** PL#19-0571 submitted by Angela Raymond on behalf of Horizon Tower LLC, proposes the construction of a new wireless telecommunication facility. The facility will consist of a 95' tall camouflaged monopole, designed to look like a conifer tree (total height with branches will be 100'), 6 antennas, equipment cabinets and a diesel generator. All components of the facility will be contained within a 40'x40' leased area. The project is located within the Rural Reserve (RRv) zoning/comprehensive plan designated area. Skagit County Code (SCC) 14.16.320 (4)(y) lists wireless communication facilities as an allowable use with an approved Special Use Permit. The project site is located at 18784 Kim Place, located within the SE ¼ of the SE ¼ of Section 31, Township 36N, Range 04 E W.M. situated within Skagit County, Washington, P119029.
