The proposed project is located within the Rural Reserve (RRv) zoning/comprehensive plan designated area as indicated in the Skagit County Comprehensive Plan and associated maps adopted July 5, 2016 and as thereafter amended. Temporary events are an allowed use in the RRv zoning designation with an approved administrative special use permit per Skagit County Code (SCC) 14.16.320(3)(m). A letter of completeness was not issued and the application was determined complete for review purposes on April 18, 2022

The project site is located adjacent to 19121 State Route (SR) 9, Mount Vernon, within a portion of Section 07, Township 33N, Range 05E W.M., situated within Skagit County, Washington (P18000, P18002 & P17972).

A completed Special Use permit application, environmental checklist, site plan, and other application materials are on file with Skagit County Planning and Development Services. This information is available to the public on request. Other governmental approvals or permits that will be required for this proposal from Skagit County Planning and Development Services include: SEPA determination, grading permit (if applicable).

A decision on the application will be made within 120 days of the date the application was determined complete, which was 4-18-22. A public hearing before the Skagit County Hearing Examiner is not required for this project. Any person desiring to express his or her views or to be notified of the action taken on the application should notify Allison Sanders in writing of his or her interest within Fifteen (15) days of the date of publication of this notice which is 4-21-22.
