Description

The Skagit Board of County Commissioners (Board) will hold a public hearing and take possible action regarding an extension of adopted Ordinance #O20250001, an interim ordinance temporarily prohibiting the acceptance of new permits for event venues on Skagit County agricultural land. The interim ordinance, effective January 14, 2025, clarifies that permissible tourism-related activities on Skagit farmland do not include permanent businesses hosting large events, such as weddings and concerts. RCW 36.70A.390 and RCW 36.70.795 authorizes the Board to renew a moratorium, interim zoning map, interim zoning ordinance, or interim official control for one or more six-month periods if a subsequent public hearing is held and findings of fact are made prior to each renewal. The interim ordinance was last extended on July 7, 2025.
