Notice is hereby given that on June 24, 2025, Skagit County Planning and Development Services approved the State Environmental Policy Act (SEPA) checklist review completed in conjunction with PLAN2-2025-0018 for the Cascade Natural Gas Burlington South Feed Pipeline Project – Phase 2. The project proposal is to install approximately 0.8 miles of 6-inch plastic natural gas distribution pipeline within the Pulver Road right of way from the intersection of Pulver Road and West McCorquedale Road south approximately 0.25 miles, then east along unopened Bennett Road right of way approximately 0.55 miles, ending at the intersection of Bouslog Road and Bennett Road. The pipeline will provide additional pressure to service customers east of the project. The project is located within the Rural Intermediate (RI) and Agricultural-Natural Resource Lands (Ag-NRL) zoning/comprehensive plan designated areas as indicated in the Skagit County Comprehensive Plan and associated maps.

**Project Location**: The site is located within the Pulver Road right of way from the intersection of Pulver Road and West McCorquedale Road south approximately 0.25 miles, then east along unopened Bennett Road right of way approximately 0.55 miles, ending at the intersection of Bouslog Road and Bennett Road. The project would be located within a portion of Section 1, Township 34N, Range 03 East, and a portion of Section 7, Township 34N, Range 04 East.

Lead Agency: Skagit County Planning and Development Services.

The lead agency for this proposal has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(C). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public on request. This determination is subject to the mitigated measures as identified below and must be deemed conditions of approval of the land use and/or permit pursuant to Skagit County Code 16.12. Such conditions are considered binding and may not be altered by subsequent decisions unless a threshold determination is reissued.

- 1. Temporary erosion/sedimentation control measures, as approved by the Skagit County Planning and Development Services, must be in place prior to the excavation and placement of fill material. The applicant must maintain all temporary erosion/sedimentation control measures in accordance with the Skagit County Stormwater Management Ordinance. Said measures must remain in place until the completion of the project.
- 2. The applicant must comply with Northwest Clean Air Agency (NWCAA) requirements.
- 3. The applicant must comply with the provisions of Chapter 14.32 of the Skagit County Code, the Skagit County Stormwater Management Ordinance, as it relates to increased runoff resulting from additional impervious surfaces. Best Management practices must be utilized throughout the life of the project.
- 4. The applicant must comply with all relevant provisions of Skagit County Code.

- 5. The applicant must obtain Hydraulic Project Approval (HPA) from the Washington Department of Fish and Wildlife (WDFW) for all works in close proximity to, and under Gages Slough except with written verification from WDFW that a HPA is not required.
- 6. Conduit installation depth must be below scour depth of Gages Slough to prevent natural scouring of the stream bed from exposure of pipeline and/or cable.
- 7. The applicant must obtain a right-of-way permit and must follow Skagit County Utility Policy requirements.
- 8. The proposal, and development must comply with all applicable requirements of SCC 14.16.
- 9. The project may be subject to one of Ecology's National Pollutant Discharge Elimination Systems (NPDES) permits. A Construction Stormwater General or Industrial Permit may be required by the Department of Ecology (WSDOE) for this project. Contact the WSDOE Northwest regional office at (360) 927-4900.
- 10. The applicant must comply with all relevant provisions of SCC 14.24 (Critical Areas Ordinance). Wetland and Critical area impacts must be fully mitigated and in full compliance with all applicable Skagit County Code requirements.
- 11. Should any human remains, archaeological, historic, or cultural materials be discovered during construction, work in the affected area must cease immediately and the area must be secured. Within 24 hours of the discovery or as soon thereafter as possible, the developer must notify the Skagit County Sheriff's Office, Skagit County Planning and Development Services, the Washington State Department of Archaeology and Historic Preservation and affected tribes. If following consultation with the above parties it is determined that an archaeological and cultural resource assessment is required, the project developer must retain the services of a professional archaeologist to prepare such an assessment. Project work in the affected area must only continue when in conformance with applicable state and federal laws.

## The Lead Agency previously issued a comment period for this proposal under the Optional DNS process outlined under WAC 197-11-355.

You may appeal this threshold determination in accordance with Skagit County Code 14.06 and 16.12 and then by filing such with the Skagit County Planning and Development Services for service to the SEPA responsible official within fourteen (14) calendar days after the date of the threshold determination.
