

**Determination of Nonsignificance and
Notice of Public Hearing on the
Skagit County Capital Facilities Plan, 2011-2016**

Description of Proposal: A non-project legislative action to update the Skagit County Capital Facilities Plan (CFP) for 2011-2016 to update County-owned and non-county-owned capital facilities inventories and cost/revenue projections for the coming six year period.

Notice of Public Hearing: Notice is hereby given that the Skagit County Planning Commission will hold a public hearing on Tuesday, November 2, 2010, at 6 p.m. in the Hearing Room of the Skagit County Commissioners Administrative Building, 1800 Continental Place, Mount Vernon, WA, for the purpose of receiving public testimony regarding the above described proposal.

SEPA Threshold Determination: Skagit County, as lead agency for this proposal, has determined that it does not have a probable significant adverse impact on the environment. An environmental impact statement is not required under the State Environmental Policy Act (SEPA) RCW 43.21C.030(2)(C). This determination was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public upon request.

This determination is issued pursuant to WAC 197-11-340(2) and WAC 197-11-630. The lead agency will not act on this proposal for fifteen calendar days of the date issued. SEPA comments regarding this Determination of Non-significance must be submitted by Tuesday, November 2, 2010, to Skagit County PDS at the address listed below. Deliveries made in person must be made by 3:30 p.m. *E-mail correspondence will not be accepted.* Pursuant to SCC 14.12.210, no administrative appeal process is available for this legislative action.
