Thank you for the opportunity to comment on an item in the upcoming agenda for January 26 (rescheduled from January 12). Our family of voting citizens of Skagit supports the request of Planning Commissioner Lundsten that the censure against him passed on September 22, 2020 be rescinded.

We are shocked that the PC would take this action. Commissioner Lundsten was perfectly within his rights to express concern to the Board of County Commissioners through the proper channels that the PC deliberative process on the heron protection proposal was flawed.

The section of the PC bylaws referenced by PC leadership in the course of the censure discussion came from this passage:

"Be respectful. Differences of opinion are inevitable. It is up to each Planning Commission member to balance the needs of his/her constituents with the needs of the community as a whole. Agree to disagree. Lose gracefully. Win honorably."

We have bolded the part that was not referenced in that discussion. In our view the admonition to "lose gracefully" (which we have never seen in bylaws anywhere before) refers to the lines above it. In our observation at numbers of PC meetings, and in Commissioner Lundsten's letter to the BoCC, he has never spoken or acted disrespectfully.

Also, in that section is this: "Members with minority views have the full right to their opinions.

Recognizing that diversity of thought is essential for good decision-making, our group will not use psychological pressure for conformity." Clearly a vote for censure is psychological pressure for conformity

It is more than puzzling to hear PC member express feeling of being "offended" by a colleague's expression of dissent. This commission is appointed to represent the community to County Commissioners to enabled their best decision-making. How can an expression of dissent in civil language through proper channels offend them?

We therefore urge the PC to correct their action and rescind the censure.

In addition, we strongly support an addition to the PC bylaws to explicitly permit a written dissenting opinion. This practice is a bedrock democratic principle practiced at all levels of government from County boards up to the Supreme Court. Minority reports or dissenting opinions are common, and make for better decision-making in democratic government. We urge you to make this simple change to the PC bylaws.

I was surprised, and frankly disturbed by the censure of Mark Lundgren over expressing to the County Commissioners his minority opinion regarding the blue heron rookery. The public has every right to know of minority opinions registered by Planning Commission members. Your censure of Commissioner Lundsten brought the dysfunction of the current bylaws and their impact on the work of the Commission to the attention of the public. I hope that you will amend the bylaws to enable minority opinions to be expressed and shared with the public. Our county government, at all levels, exists to serve the public and can only be trusted when there is transparency behind the decisions made. Many citizens, as well as a manager from the Department of Fish and Wildlife, spoke in favor of the heronry ordinance, and yet the Commission voted against it. The explanations given during the meeting indicated the decision was based on personal observations, not on science, and revealed how the Commission had not read or listened to the public comments. To restore public faith in the Commission I ask you to amend the current bylaws to allow for minority opinions among the commissioners to be recorded and presented both to the Board of County Commissioners and to the public. A growing number of Skagit County citizens are concerned about the Planning Commission's conduct and decisions.
