## Meeting Minutes (01/26/21)

Chair Raschko introduced the meeting minutes from the last meeting (01/26/21) for proposed changes and approval. Commissioner Mitchell moved to approve the meeting minutes and Commissioner Rose seconded it. The Commissioners voted unanimously to approve the motion.

#### Censure Discussion

This is a discussion concerning the censure of Commissioner Lundsten which occurred at a Planning Commission meeting on September 22, 2020. Chair Raschko commenced this portion of the meeting by giving the floor to Commissioner Lundsten. Commissioner Lundsten brought up points which are discussed in his letter sent to the Planning Commissioners on January 11, 2021. Commissioner Lundsten moved to remove the censure placed on him. Commissioner Rose seconded this motion. The floor was open to conversation among the commissioners.

Each commissioner spoke to give comment on the motion. The motion went to a vote and was denied 3-6.

# Shoreline Master Program Update

This work session commenced with a quick introduction of the Shoreline Master Program Update by Senior Planner Stevenson and consultant from the Watershed Company, Mr. Daniel. Planner Stevenson recapped the last work session and the virtual public open house. Mr. Daniel took over the presentation and introduced policy changes that will be considered and included in the SMP this year. This included a language changes, boundary line designations, environmental protection as it relates to the Critical Areas Ordinance, markers at public access points to aid first responders, and vegetative conservation goals. Stevenson and Daniel took questions and comments from the Planning Commissioners.

## <u>Director's Updates</u>

Director Hart led this portion of the meeting with an update on Washington State Legislation that is currently being considered at the State level and how these bills might affect Skagit County. Director Hart went into a discussion of the biggest issues affecting the County and the Planning Department including, the uptick in people retiring, tracking of the permitting process, the influx of permit applications due to the Washington State building code update, and the water issues Skagit County faces with permitting. Long Range Planner Peter Gill ended this section with closing follow up items, including a brief on the next meeting, the upcoming 2020-2021 Docket, the SMP public meeting, and Ms. Dover's departure from her role as Intern.

## Planning Commission Announcement/Comments

Commissioner Rose commented to bring the Planning Commission's attention to Commission Bylaws. Commissioner Hughes, Candler, Mitchell, and Raschko expressed thanks and good luck to outgoing intern, Ms. Dover.
