### **Summary of Meeting**

#### Roll Call

Chair Raschko began the meeting with a roll call.

#### Approval of Minutes (2/8/2022)

Chair Raschko introduced the meeting minutes from the last meeting (2/8/2022) for approval. A motion to approve the February 8th meeting minutes was initiated by Commissioner Henley and was seconded by Commissioner Mitchell. There was no discussion and the minutes were approved unanimously.

#### Public Remarks (Video at 00:03:00)

Chair Raschko opened the meeting for public comment on any issue. Patrick Donnelly provided comment on his application for the 2020-2021 planning docket.

Deliberations on the 2021 Planning Docket (Video at 00:07:35)

Long Range Planning Manager Peter Gill and Assistant Long Range Planner Jenn Rogers presented background information on LR20-07 and LR21-02.

Chair Raschko then opened deliberations for the 2021 Planning Docket. The Planning Commission voted on remaining two citizen initiated petitions in the following manner:

- LR20-07 Accessory Dwelling Unit Code Amendment
  - Commissioner Candler moves for the petition to be denied, but that the Board of County Commissioner recommend to the Planning Department to change the code to reflect 1200 square foot accessory dwelling units and to remove the condition that the dwelling unit be only 50% of the size of the primary residential unit. The motion was seconded by Commissioner Mitchell.
  - The motion to **deny** passes 6-1-0 with Commissioner Woodmansee voting nay and Commissioner Hughes absent.
- LR21-02 Clarify CaRD Land Divisions and the "Reserve" Function
  - Commissioner Woodmansee moves for the petition to be denied, seconded by Commissioner Mitchell.
  - The motion to deny passes unanimously.

Chair Raschko called a vote to approve the 2021 Planning Docket recorded motion. The vote passed unanimously. More information regarding the 2021 Planning Docket and related documents are available at
