#### **Approval of Minutes**

#### Work Session – Development Regulations and Critical Areas Update

Staff noted that the review materials were provided later than the one week prior to the meeting. Robby Eckroth mentioned that this work session intent to guide the PC's review of materials that were provided. Ryan Walters provided an overview of changes to the draft reorganization of SCC Title 14. This is summarized in the <a href="April 21">April 21</a>, 2025 memo. Next segment of the work session was a presentation of the Critical Areas Ordinance (CAO) draft update changes provided by Dan Nickel. These draft changes are summarized in the <a href="April 15">April 15</a>, 2025 memo.

Nickel explained that the <u>Best Available Science (BAS) report</u> and the <u>Gap Analysis Report</u> influenced the proposed draft updates.

## **Department Updates**

Next meeting on May 6<sup>th</sup> will be the Public Hearing for the Draft Development Regulations and Critical Areas Update and May 20<sup>th</sup> will be deliberations. There is a work session scheduled with the Board on the Comprehensive Plan update that will include a presentation of the PC recommendations on the update.
