#### Work Session: Stormwater Code Update

Agritourism Policy Options and Public Engagement Update

Lisa Grueter, BERK Consulting Principal, introduced the agritourism policy options report and discussed the different options for agritourism in Skagit County. BERK Consulting and Skagit County Planning & Development staff hosted two public workshops and opened an online survey on the proposed options to take feedback and comments. Lisa presented the responses to the survey and comments received during the workshops.

Director's Update


Director Hal Hart updated the Planning Commission on continued growth and new housing developments in the County. He then provided an overview of the ongoing negotiations on the Shoreline Master Program with the Board of County Commissioners and the anticipated schedule for adoptions.

Jenn Rogers then shared the recent work sessions the Board of County Commissioners has held on the 2022 planning docket and where the Planning Commission can find the staff report with the Department's recommendations on which petitions should be included on the docket.


