Approval of Minutes (05/11/2021)

Chair Raschko introduced the meeting minutes from the last meeting (05/11/2021) for approval. A motion to approve the May 11th meeting minutes was initiated by Commissioner Mitchell and was seconded by Commissioner Henley. The minutes were approved unanimously.

Jason D'Avignon was introduced from the Prosecuting Attorney's office to assist with the Planning Commission's legal questions.

One resident expressed desire to participate in Agritourism but has ran into regulatory obstacles, as a business may not be allowed to grow, process, and serve to costumers all in the

same place. There was another comment that was concerned about certain Agritourism uses such as restaurants being developed in areas that don't have adequate infrastructure.

Mr. Gill went over Phase 1 of the Agritourism project (public outreach) and emphasized the usefulness of the virtual Small Discussion Groups. Lisa Grueter highlighted results of the Survey, Small Group Discussions, and the Next Steps in this project. Mr. Gill and Ms. Grueter answered questions from the Commissioners. Bylaws Work Session [01:10:10]

Chair Raschko opened the session by inviting Commissioner Rose to voice her concerns over the bylaws. After some discussion, the Planning Commission decided by consensus against implementing term limits. Other topics included questions about conflict of interest, confidential information, emergency meetings, and communication amongst Commissioners.

The Planning Commission unanimously approved an amended motion by Commissioner Mitchell to revise line 26 of page 1 of the bylaws. The sentence "to this end, the Planning Commission shall work to promote the best interest of the County over time" was changed to say "to this end, the Planning Commission shall work to promote the best interest of the people of the county over time". A motion to have a clean copy of the bylaws prepared for easier readability was initiated by Commissioner Henley, seconded by Commissioner Hughes and approved unanimously.

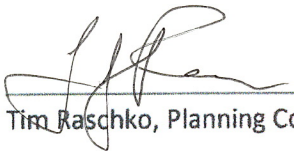
Director's Update [02:10:45]

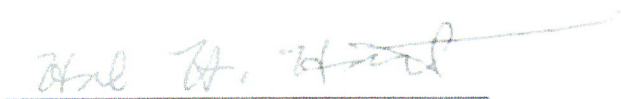
