Shoreline Master Program (SMP) Update Work Session (Watch Video Recording at 00:05:00)

Long Range Planning Manager Peter Gill began by providing an overview of what has been covered and the how the Planning Commission can respond to the abundance of feedback that has been received on the SMP. Staff continued noting that feedback from the Planning Commission members is used to draft the Planning Commission recorded motion. Dan Nickel from the Watershed Company discussed previous department recommendations, and went over what department recommendations have changed on the Public Comment and Response Matrix. Mr. Nickel then went through the public comments by category one page at a time, addressing Commissioners' concerns or questions as they came up. Planning Director Hal Hart discussed permitting, development, and the growing employment numbers in Skagit County. Mr. Hart next covered the monthly meeting that occurred with the Agricultural Advisory Committee where the Voluntary Stewardship Program was discussed. Mr. Gill discussed upcoming dates within the department, including the Board approving the updated building codes on August 24th, the next Planning Commission meeting to happen on September 28th, and other upcoming items such as the 2022 Docket, the update to the Capital Facilities Plan and Agritourism. Lastly, Mr. Gill noted that the Planning Commission is looking for applicants in District 3 to fill a vacant seat.
